FEA releases PreK-12 reopening recommendations

Virtual news conference planned for 1 p.m. today

TALLAHASSEE — Final recommendations for reopening PreK-12 public school campuses were released today, June 2, by the Florida Education Association (FEA). The recommendations, attached, will be discussed at a virtual news conference at 1 p.m. EDT.

The PreK-12 recommendations are the work of the 25-member Statewide Committee to Safely Reopen Florida's Public Schools, which was organized by the FEA and brings together a diverse group of stakeholders invested in the success of our students and public schools. The committee began work on May 21 to develop recommendations in five areas: Ensuring Student Success, Social and Emotional Wellness and Support, Safe Working and Learning Conditions, Investment in Our Neighborhood Public Schools, and Public Health and Safety.

"These recommendations are meant as a foundation, as a floor to discussions on how to reopen schools. They are a conversation starter with input from the people who know our students and schools best," said FEA President Fedrick Ingram, who served as committee chair. "There are only about 70 days before our students are scheduled to return to campuses. It is imperative that we move forward now to make that return safe and successful. We look forward to working with the education commissioner and local districts to bring about the best possible outcomes for kids."

They brought to their work a deep well of knowledge about Florida's students, public schools and communities, along with a deep commitment to acting in the best interest of all of our state's children.

Voices from the Statewide Committee to Safely Reopen Florida's Public Schools

Carol Cleaver, Escambia County teacher, facilitator of Student Success subcommittee

"During this pandemic, students and educators have had their worlds turned upside down. Through the end of the school year, teachers made a valiant effort to continue academic instruction in as consistent a way as possible — but we must be honest and admit that performing under these types of circumstances does not allow for the high quality education and face-to-face relationships that students deserve. We must further acknowledge the likelihood of interruptions and contingencies in the school year to come, and make every effort to protect the instructional time we do have with students.

"The focus needs to be on achieving academic progress. Determining a student's ability to perform on a standardized test or school improvement percentages should not be our concern when we are endeavoring to make up for lost time from last school year and remain adaptable in the year to come. School testing and evaluations should not be conducted in the 2020-2021 school year.

"While school year calendars and curriculum platforms may be determined by administrators and legislators, it is the teachers and education staff professionals themselves who ultimately do the work of educating children. Please capitalize on our experience, input and concern for Florida's children by bringing us to the planning table."

"The Working Conditions subcommittee members strongly support compliance with the CDC recommendations because those guidelines are based on science. My group acknowledges that following the CDC's guidance will be challenging and costly, but our first priority has to be the safety and well-being of our students, the teachers, and their families. If decisions are based on considerations other than preventing the spread of this virus, it is a near certainty that students, faculty members and families will get sick. Our recommendations reflect our understanding that taking the advice of doctors and scientists will lead to better outcomes for our stakeholders than decisions made based on the ease of their implementation. "
