MISSION

The Florida School Boards Association, Inc. (FSBA) is a nonprofit corporation representing the elected school boards in Florida. FSBA has been the collective voice for Florida school districts since 1930. With Florida's 67 school districts and 358 elected school board members, FSBA is closely allied with other educational and community agencies to work toward improvement of education in Florida.

The MISSION of the Florida School Boards Association is to increase student achievement through the development of effective school board leadership and advocacy for public education.

Governance Structure

Executive Officers

The FSBA Executive Officers include the President, President-Elect, Vice President, Treasurer, and Immediate Past President. In addition, the FSBA Executive Director serves as an ex-officio member of the Executive Officers. All Executive Officers except the Immediate Past President, President, and the Executive Director are elected by ballot of a majority of the membership in attendance at the Annual Meeting of the Association.

Board of Directors

The FSBA Board of Directors is composed of the five Executive Officers, 27 Directors representing geographical districts in the state, and FSBA members who serve as an officer or member of the Board of Directors of the National School Boards Association or the Southern Region School Boards Association. These Directors serve two-year staggered terms. The Board of Directors' meets four times annually to establish positions and provide direction on major issues that directly impact the Association's activities.

Committees

The work of FSBA Committees is essential for the Association to carry out its Mission and Strategic Goals. The FSBA Bylaws establish three types of committees: Standing Committees for ongoing action; Ad Hoc Committees to explore topics or issues of special interest; and Nominating Committee to recommend a slate of candidates for FSBA executive officer positions. The FSBA President, in consultation with the other Executive Officers, appoints the Chair and Vice Chair of each committee, consistent with requirements set forth in the Bylaws and Policies.

General Membership

The FSBA General Membership consists of active members across the state. Per the Florida Constitution, there are 358 total school board members representing Florida's 67 public school districts. The General Membership meets to conduct business twice annually in conjunction with the FSBA/FADSS Annual Summer and Joint Conferences. All policy and by-law changes, elections of officers, and budget approval must be voted on by the General Membership.

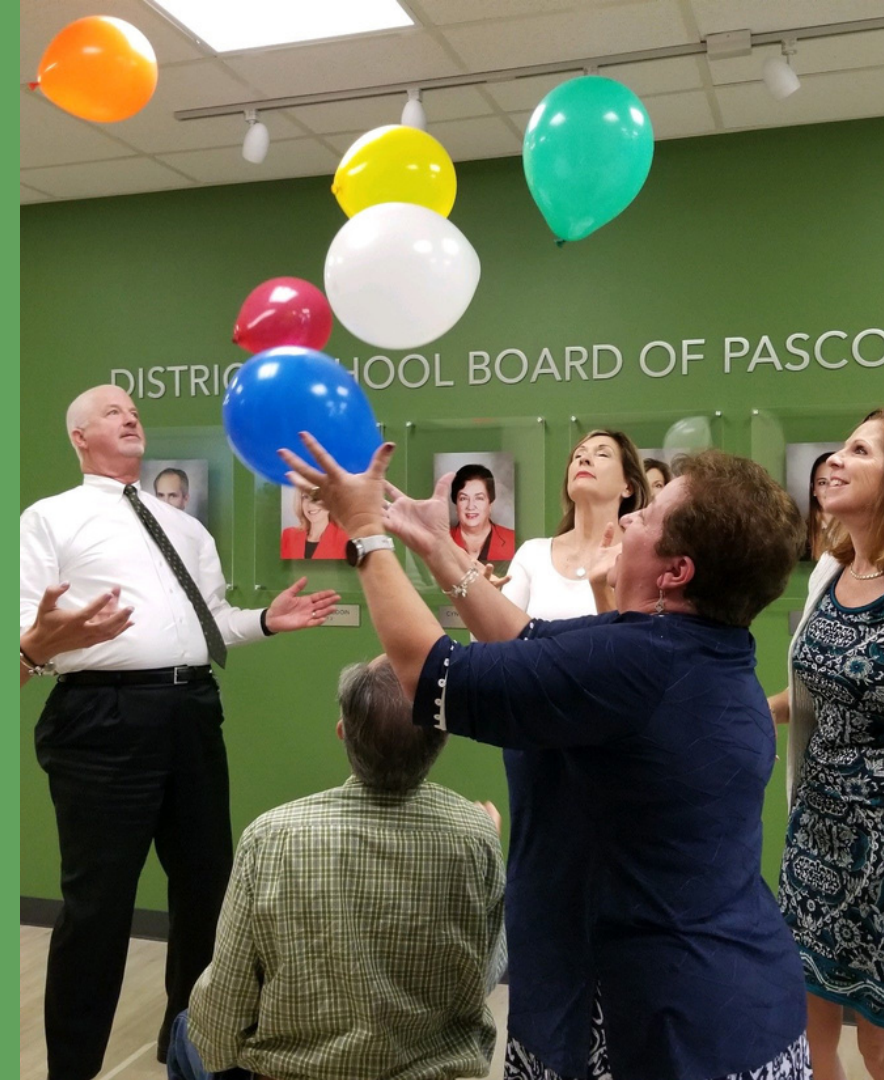

Our members have access to custom reports, on-call consultation, up-to-date legislative reports and analyses, exclusive cost-saving opportunities for their districts, and many other services.

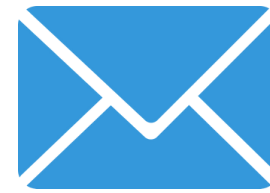


Leadership Services
