Help lead YOUR professional membership organization OR suggest someone else to lead!

Executive officer nominations are open today through March 18, 2022. I encourage you to consider nominating yourself for consideration or encouraging another school board leader to complete the application process to be considered for a leadership position in FSBA.

1. Declaration of Candidacy materials must be received in the FSBA office by 5:00 p.m. EST on Friday, March 18, 2022. This deadline allows time to disseminate the applications for review by the Nominating Committee before the committee meets in April.
2. The FSBA Nominating Committee will meet on Monday, April 11, 2022, via GoToMeeting to interview candidates for the positions of **President-Elect, Vice President, and Treasurer**. Thomas Kennedy, currently FSBA President-Elect, will assume the office of President by FSBA Bylaws. As Immediate Past President of FSBA, I will chair the committee.
3. The slate selected by the Nominating Committee will be recommended for election at the General Membership business meeting of FSBA in June 2022.

The Declaration of Candidacy is available by clicking [here](#) or you can request a copy be sent to you by contacting the FSBA office. If you are applying or recommending someone else, please consider the time commitment and travel requirements expected of those who serve. Be sure your local school board is aware of your desire to serve and is supportive of your undertaking, or that this is true of your nominee. Per section 1015 of FSBA Policy Manual, a candidate shall not solicit the support or the endorsement of school board members on the Nominating Committee which was elected at the December General Membership meeting. Those elected to serve on the Nominating Committee are Mary Bolla, Eric Cummings, Victoria Defenthaler, Dr. Karen Castor Dentel, Megan Harding, Debbie Jordan, Linda Sanborn, Dr. Mara Schiff, Roy Terry, and, Rosanne Wood. The alternates are Ruben Colon, Ed daSilva, Lynn Gray, Kim Kirby, and, Christia Li Roberts.
