This amendment will remove references to the prior version of threat assessment from this rule that are set to expire on December 31, 2023, and will govern maintenance and transfer of threat management records consistent with s. 1003.25, F.S.

Purpose: The purpose of the rule development for Rule 6A-5.069 is to include a system-wide shift from "professional development" to "professional learning" with definitions and criteria provided; to establish a format and calendar for the review and approval of professional learning systems by March 1, 2024; and to create a web-based marketplace for high-quality professional learning programs and establish Department criteria for districts who may seek to contract with independent entities who offer professional learning programs as outlined in House Bill (HB) 1537. The purpose of the rule development for Rule 6A-5.071 is to prohibit "three-cueing" as an instructional strategy and establish criteria for professional learning entities and contracted professionals as outlined in HB 1537 and HB 7039.

Purpose: The Department is revising requirements of the District K-12 Comprehensive Evidence-Based Reading Plan based on changes included in House Bills 7039 and 5101. Revised requirements include: additional screening, required parent notification, and definition of dyslexia-specific interventions for students who show characteristics of dyslexia; notification to parents of eligible students for New Worlds Scholarship Accounts; prioritization of highly effective teachers in K-2 classrooms; assignment of literacy coaches; ensuring reading instruction and professional learning are grounded in the science of reading; prohibition of three-cueing in the teaching of word reading; and including all district schools including charter schools, unless a charter school elects to submit a plan to the sponsoring Local Educational Agency independently from the school district that complies with all of the plan requirements. Additional changes to remove outdated language and to clarify reading plan requirements will also be considered. This is the second rule development workshop being held for Rule 6A-6.053, F.A.C.

Purpose: Florida has recently transitioned to a new statewide, standardized assessment, pursuant to s. 1008.22, as amended by Senate Bill (SB) 1048 (2022). The proposed changes align rule language with the terminology adopted in October 2023 for the new statewide, standardized assessments in Rule 6A-1.09422, F.A.C., and remove references to the "Florida Standards Assessment (FSA)" and the "Florida Standards Alternate Assessment (FSAA)." The effects will include updates but there will be no substantive changes in standards and requirements for an English Language Learner (ELL) to exit from the ESOL Program.
