Rule No.: 6A-10.0401

Purpose: Facilitates the statewide articulation of industry certifications pursuant to sections 1007.23 and 1008.44, F.S., which require the Articulation Coordinating Committee to recommend articulation agreements to the State Board of Education that provide for the articulation of postsecondary credit toward related degrees for earned industry certifications. Purpose: The rule establishes the programs and courses that are funded through the Florida Education Finance Program (FEFP) and available for students to take to earn credit toward high school graduation. The programs and courses are listed in the "Course Code Directory and Personnel Assignments", which is revised on an annual basis prior to the end of the current school year to add new courses, as approved by the Commissioner, remove expired or deleted courses, and provide updates based on current law.
