Purpose: This rule development was originally posted on 4/25/2024, Vol. 50/82, with an incorrect link for the workshop. The link below has been updated. To incorporate the school grading scale for the 2023-24 school grades results and to incorporate technical changes to update alternate assessment language to align with language in Rule 6A-1.0943, F.A.C., and remove reference to the English Language Proficiency Assessment, which is no longer used in the determination of learning gains for English Language Learners.

Purpose: The rule amendment will add AMH X010 to meet the civic literacy competency course requirement. CLEP History of the United States I will also be added as an additional option for students to meet the civic literacy competency assessment requirement. In addition, HB1285 (2024) created a new degree type (associate in arts specialized transfer degree) that must be added to this rule since civic literacy competency is a graduation requirement. Additionally, technical changes have been made for purposes of clarity and consistency. The effect of this amendment will require colleges to modify their policies, procedures, advising practices and catalogs regarding the additional new course option.

Purpose: Senate Bill 7016 (2024) amended section 1009.8962, Florida Statutes so that additional postsecondary institutions, such as independent schools, colleges, and universities licensed by the Commission for Independent Education (CIE), may participate in the Linking Industry to Nursing Education (LINE) Fund as long as they meet the outlined accreditation requirements and meet CIE's licensing requirements. Senate Bill 7016 also increased the required passage rate for the licensing examination for licensed practical nursing (LPN) programs and for associate and bachelor of science nursing programs and established a minimum number of test takers. Therefore, current rule language will be updated to reflect these changes. Additional changes to the disbursement requirements will also be considered.

Purpose: To update the Florida Site Visit Framework to align with s. 1004.04, F.S., requiring a minimum of 12 weeks of student teaching. The Department will update the Florida Site Visit Framework to provide clarity on specific review areas. Amendments will be added to the rule to require specific programs to include the reading endorsement competencies. These changes will include adding the Exceptional Student Education certification subject area as being required to receive training in all five reading endorsement competencies, resulting in candidates earning the reading endorsement. The Exceptional Student Education change aligns with s. 1004.04(2)(c), F.S., and Rule 6A-4.0051, F.A.C. Additional considerations to the Annual Program Performance Report metrics will ensure that Florida maintains high-quality educator preparation programs.

Purpose: The purpose of this rule is to set forth requirements relating to school safety and to define certain safety measures that schools are expected to meet. Amendments will incorporate changes from House Bill 1473 (2024), address changes as a result of the final transition to the Florida Harm Prevention and Threat Management Model, and add additional requirements for emergency drills and Alyssa's Alert implementation. Other general matters relating to school safety monitoring, reporting and training will also be considered.

Purpose: Currently the Division of Vocational Rehabilitation (VR) reviews each individual written request for a waiver of confidentiality and the release of protected and confidential client information to determine if it is adequate for use. This rule revision will adopt a single waiver of confidentiality form as a required part of rule to streamline VR's review and approval process and ensure all requests for client information meet the requirements set forth in law.

Purpose: The purpose of this rule is to set forth requirements for a statewide, Florida-specific threat management operational process and threat management instrument. The effect of the amendment is to update the threat management manual, instrument, and training requirements, and to clarify the definitions of "school" and "district" to address college and university-sponsored charter schools. The amended rule also removes outdated language and
