The rule on Private School Scholarship Compliance, 6A-6.03315, will also further define certain actions that constitute operating a private school in a manner contrary to the health, safety, and welfare of the public and create an imminent threat to the health, safety, or welfare of the school's students.

Purpose: The Summer Bridge Program is established within the Department pursuant to HB 5101, which amended s. 1008.25, F.S. A Voluntary Prekindergarten (VPK) student who scores below the 10th percentile on the final administration of the coordinated screening and progress monitoring system (PM3), pursuant to s. 1008.25(9), F.S., is eligible to receive early literacy skill instructional support through the Summer Bridge Program before entering kindergarten. The Department will notify parents of student eligibility. Districts must report student participation,

including the number and percentage of eligible children participating and their student FLEIDs.

Purpose: The purpose of the rule development is to incorporate legislative changes from House Bill 1285 (2024), Senate Bill 7002 (2024) and Senate Bill 7004 (2024), which amend Sections 1008.33 and 1012.2315, Florida Statutes, and add requirements for school districts and charter school operators when the school districts select a charter turnaround option plan in the school improvement turnaround process. The rule changes under consideration are to define inexperienced teachers, clarify other requirements such as student enrollment, grade levels, rental or leasing fees, and administrative fees. Amendments may address a provision to allow the State Board to give a community partnership school additional time to implement a community school model. Additional amendments to turnaround requirements may be added.
