Purpose: The purpose of this rule amendment is to adopt new Florida Teacher Certification Examinations (FTCE) passing scores, effective January 1, 2025, for the following FTCE test areas: English for Speakers of Other Languages (ESOL) K–12; Exceptional Student Education (ESE) K–12; English 6–12 (both subtests: Multiple-Choice and Writing); Middle Grades English 5–9 (both subtests: Multiple-Choice and Writing); Mathematics 6–12; Middle Grades Mathematics 5–9; Music K–12; Reading K–12; Speech-Language Impaired K–12; Elementary Education K–6 Subtest 1: Language Arts and Reading; Elementary Education K–6 Subtest 4: Mathematics; Prekindergarten/Primary PK–3 Subtest 2: Language Arts and Reading; Prekindergarten/Primary PK–3 Subtest 3: Mathematics; and the General Knowledge test (all four subtests: Essay, English Language Skills [ELS], Reading, and Mathematics).

Purpose: The purpose of this rule amendment is to align it with changes from the 2024 legislative session due to House Bill 865. The amendment is to revise the requirements for athletic coaches to now include certification in the use of an automatic external defibrillator and first aid. Currently athletic coaches are only required to have certification in cardiopulmonary resuscitation.
