Rule No.: 6A-5.078

Purpose: The purpose of the rule is to support implementation of Section 1012.56, Florida Statutes, as amended by Senate Bill 7002 (2024). The statutory amendment allows certified educators to place their certificates in an inactive status and requires the department to prescribe professional learning requirements that educators must complete to reactivate a certificate that has been inactive for more than one year.

Purpose: To revise existing requirements of the statewide comprehensive management information system to implement changes recommended by school districts and to change state reporting and local recordkeeping procedures for state and/or federal programs as described in the updated FDOE Information Database Requirements. The rule also adopts the updated FDOE Information Database Requirements: Volume I - Automated Student Information System, 24-25 and Volume II - Automated Staff Information System, 24-25. The effect maintains compatibility among state and local information systems' components. The statewide comprehensive management information system provides the data on which the measurement of school improvement and accountability is based

Purpose: The purpose of this amendment is to revise the name of the statewide, standardized alternate assessment from the Florida Standards Alternate Assessment (FSAA) to the Florida Alternate Assessment (FAA), to adjust the scoring pattern for the FAA—Datafolio; and to specify score ranges that define the Achievement Levels for the FAA—Performance Task aligned to the Benchmarks for Excellent Student Thinking (B.E.S.T.) Standards Access Points in English Language Arts (ELA) and Mathematics.

Purpose: The amendment updates the rule that governs the administration of the Hope Scholarship Program. House Bill 1403 (2024) streamlined many of the provisions to the Hope Scholarship Program, including its original funding source (sales tax contributions from motor vehicle sales) and merged it with the Florida Tax Credit Scholarship, but its requirements for parental notification for the incidents in s. 1002.40(3), F.S., remain.

Purpose: The proposed amendment to this rule updates its name by removing the word "Reading," as mathematics scholarships are available, as passed in HB 7039 (2023). The new name will be New Worlds Scholarship Accounts. Other technical changes are being proposed, including updates and quarterly reporting requirements.
