Purpose: To establish a re-entry pathway for private prekindergarten providers and public schools that must meet the contract minimum threshold on the program assessment to participate in the Voluntary Prekindergarten (VPK) Education Program in accordance with Section 1002.68(5)(a), F.S. Additionally, the proposed amendment requires observation notes to be provided with the composite program assessment score, updates procedures for second program assessments and revises program assessment requirements for programs that undergo an ownership change before the end of the school year.
