Revisions include a new definitions section, updated requirements for Florida College System institutions, striking the incorporated form, and other technical changes. The updates will clarify policies regarding the classification of Florida College System students regarding residency for purposes of determining in-state tuition.

This amendment also clarifies that students in 450 hour or greater Applied Technology Diploma (ATD) programs must demonstrate knowledge of basic skills.
