[HB 1](#) – The Hope Scholarship Program by Donalds (I: [SB 1172](#) by Galvano)

Establishes Hope Scholarship Program; provides program purpose & requirements; authorizes certain persons to elect to direct certain state sales & use tax revenue to be transferred to nonprofit scholarship-funding organizations for Hope Scholarship Program; provides penalties; authorizes DOR to adopt emergency rules for specified purposes.

[SB 4](#) – Higher Education by Galvano (I: [HB 423](#) by Rodrigues)

Citing this act as the "Florida Excellence in Higher Education Act of 2018"; establishing the World Class Faculty and Scholar Program; authorizing state university investments in certain faculty retention, recruitment, and recognition activities; authorizing a student to use Florida Bright Futures Scholarship Program awards for summer term enrollment; extending coverage of the Benacquisto Scholarship Program to include tuition and fees for qualified nonresident students, etc.

[HB 7](#) – Local Government Fiscal Transparency by Burton (S: [SB 1426](#) by Lee)

Revises Legislative Auditing Committee duties; specifies purpose of local government fiscal transparency requirements; requires local governments to post certain voting record information on websites; requires property appraisers & local governments to post certain property tax information & history on websites; requires public notices for public hearings & meetings prior to certain increases of local government tax levies; requires local governments to conduct debt affordability analyses under specified conditions; etc.

[HB 9](#) – Federal Immigration Enforcement by Metz (S: [SB 308](#) by Bean)

Prohibits sanctuary policies; requires state & local governmental agencies to comply with & support enforcement of federal immigration law; provides whistle-blower protections; prohibits expenditure of public funds for specified purposes; provides cause of action for personal injury or wrongful death attributed to sanctuary policy; requires repeal of existing sanctuary policies; etc.

[HB 11](#) – Government Accountability by Metz (S: [SB 354](#) by Stargel)

Requires Governor & Commissioner of Education, or their designees, to notify Legislative Auditing Committee of entity's failure to comply with certain auditing & financial reporting requirements; revises certain lodging rates for purpose of reimbursement to specified employees; provides requirements for statewide travel management system; revises responsibilities of specified entities to include establishment & maintenance of certain internal controls; revises auditing requirements for certain agencies, councils, & state schools; requires the Legislative Auditing Committee to determine whether governmental entity should be subject to state action under certain circumstances; etc.

[HB 15](#) – Deregulation of Professions & Occupations by Beshears (S: [SB 526](#) by Bracy)

Removes regulations on specified DBPR professions; revises certain requirements for barbers, nail specialists, business organizations that provide architecture services and interior design, landscape architects, & geologists.

[HB 25](#) – Labor Organizations by Plakon (I: [SB 1036](#) by Steube)

Revises required information to be included in application for renewal of registration of employee organization; provides for revocation of certification under certain conditions; requires certain employee organizations to recertify as certified bargaining agents; provides nonapplicability with respect to employee organizations that represent or seek to represent certain employees.

[HB 43](#) – Campaign Financing by Gruters (S: [SB 122](#) by Steube)

Revises definition of term "contribution"; revises schedule governing campaign finance reporting for candidates, political committees, & electioneering communications organizations; revises reporting requirements; prohibits political committee or an electioneering communications organization from transferring funds to certain entities; etc.

[HB 49](#) – Internship Tax Credit Program by Jones (S: [SB 318](#) by Powell)

Authorizes corporate income tax credit up to specified amount for degree-seeking student hired by certain businesses after internship by student; provides eligibility criteria; authorizes DOR to adopt rules governing applications & establish qualification requirements; authorizes business to carry forward tax credit for specified period.

[HB 63](#) – Students with Disabilities in Public Schools by Edwards (I: [SB 260](#) by Book)

Provides requirements for use of seclusion, restraint, & exclusionary & nonexclusionary time; revises school district policies & procedures; requires continuing education & inservice training relating to students with certain disabilities.

[HJR 65](#) – Vote Required to Approve Constitutional Amendment by Roth (I: [SJR 978](#) by Baxley)

Proposes amendment to State Constitution to increase percentage of elector votes required to approve amendment or revision to State Constitution from 60 percent to 66 & 2/3 percent.

[SB 66](#) – Prohibited Discrimination by Rouson (S: [HB 347](#) by Diamond & Plasencia)

Creating the "Florida Competitive Workforce Act"; adding sexual orientation and gender identity as impermissible grounds for discrimination in public lodging establishments and public food service establishments; revising the purposes of the Florida Civil Rights Act of 1992 to conform to changes made by the act, etc.

[SB 70](#) – State Investments by J. Rodriguez (S: [HB 359](#) by Nunez, [SB 538](#) by Garcia)

Requiring the State Board of Administration to divest investments with the government of Venezuela; prohibiting the State Board of Administration and state agencies from investing in any institution or company that does business with or invests in the government of Venezuela; authorizing the Governor to waive the investment prohibitions if certain conditions exist, etc.

[HB 75](#) – Postsecondary Fee Waivers by Ponder (S: [SB 460](#) by Gainer)

Authorizes FCS institutions to waive portion of certain postsecondary fees for active duty members of U.S. Armed Forces using military tuition assistance; requires FCS institutions to report to SBE number & value of such fee waivers granted annually.

[HB 79](#) – Public Meetings by Roth (S: [SB 192](#) by Baxley)

Specifies conditions under which members of board or commission of state agency or authority or of agency or authority of county, municipal corporation, or political subdivision may participate in fact-finding exercises or excursions.

[HB 83](#) – Agency Rulemaking by Spano (S: [SB 912](#) by Broxson)

Requires agency to prepare statement of estimated regulatory costs before adopting or amending certain rules; requires agency to provide notice of revision for statement of estimated regulatory cost; etc.

[SB 88](#) – High School Graduation Requirements by Hukill (I: [HB 323](#) by Fitzenhagen)

Revising the requirements for the Next Generation Sunshine State Standards to include financial literacy; revising the required credits for a standard high school diploma to include one-half credit of instruction in personal financial literacy and money management and seven and one-half, rather than eight, credits in electives, etc.

[HB 89](#) – Actions Against Contractors/Required Insurance Coverage by Spano (I: [SB 604](#) by Steube)
Provides that contractor who fails to carry required insurance may be personally liable for damages that would have been covered by such insurance.

[SB 92](#) – Children in Motor Vehicles by Book (I: [HB 115](#) by Slosberg)
Children in Motor Vehicles; Prohibiting a parent, legal guardian, or other person responsible for a child younger than a specified age from leaving the child unattended or unsupervised in a motor vehicle for any length of time, etc.

[SB 96](#) – Human Trafficking Education in Schools by Steube
Revising the required health education in public schools to include information regarding the dangers and signs of human trafficking; authorizing a student to opt out of a specified portion of the health education under certain circumstances, etc.

[SB 102](#) – Discrimination in Employment Screening by Bracy (I: [HB 433](#) by Henry)
Prohibiting an employer from inquiring into or considering an applicant's criminal history on an initial employment application unless otherwise required to do so by law, etc.

[HB 105](#) – Resign-to-run Law by Santiago (I: [SB 186](#) by Hutson)
Requires officer who qualifies for federal public office to resign from the office he or she presently holds if the terms, or any part thereof, run concurrently; prescribes resignation requirements; provides for automatic irrevocable resignation in the event of noncompliance; specifies that resignation creates a vacancy in office.

[HB 111](#) – Department of Management Services by Albritton(S: [SB 368](#) by Brandes)
Creates task force to evaluate procurement laws & policies & make specified recommendations; specifies membership of task force; provides for administrative & technical support of task force; requires task force to submit report to Governor & Legislature by certain date; etc.

[SB 112](#) – Involuntary Examinations/Baker Act by Campbell (I: [HB 573](#) by Daniels)
Authorizing physician assistants and advanced registered nurse practitioners to execute a certificate under certain conditions stating that they have examined a person and find the person appears to meet the criteria for involuntary examination, etc.

[HB 113](#) – Concealed Weapons / Multiuse Facilities by Fitzenhagen (I: [SB 274](#) by Stargel)
Provides that person licensed to carry concealed weapon & concealed firearm is not prohibited by specified laws from such carrying on property of certain institutions.

[HB 115](#) – Children in Motor Vehicles by Slosberg (I: [SB 92](#) by Book)
Prohibits parent, guardian, or other person responsible for child younger than specified age from leaving child unattended or unsupervised in motor vehicle for any length of time; provides penalties.

[SB 118](#) – Visitation of Schools by State Legislators by Hukill (I: [HB 975](#) by Grant)
Authorizing a member of the Legislature to visit any district school in his/her legislative district, etc.

[SB 122](#) – Campaign Financing by Steube (S: [HB 43](#) by Gruters)
Modifying and clarifying the schedule governing campaign finance reporting for candidates, political committees, and electioneering communications organizations; prohibiting a political committee or an electioneering communications organization from transferring funds to certain entities; etc.

[SB 126](#) – Workers' Compensation for First Responders by Torres, Jr. (I: [HB 629](#) by Asensio)
Revising the standard by which a mental or nervous injury must be demonstrated for eligibility for benefits for employment-related accidents and injuries; removing limitation on medical benefits; etc.

[HB 161](#) – Mandatory Retention by J. Cortes (I: [SB 294](#) by J. Rodriguez)

Removes requirement for mandatory retention of third grade students based on performance on ELA assessment.

[HB 165](#) – Threats to Kill or Do Bodily Injury by McClain (S: [SB 310](#) by Steube)

Prohibits person from making threat to kill or do bodily injury in writing or other record & transmitting that threat; removes requirements that threat be sent to specific recipient; provides penalty.

[SB 166](#) – Minimum Wage by Rodriguez (S: [HB 1441](#) by Jacquet)

Revising the formula for the adjusted state minimum wage, etc.

[SB 180](#) – Computer Coding Instruction by Brandes

Authorizing, but not requiring, high schools to offer students opportunities to take specified computer coding courses; requiring the Commissioner to identify courses that satisfy two credits of sequential foreign language instruction; etc.

[HB 181](#) – Sunshine Scholarship Program by Jones (S: [SB 794](#) by Braynon; [SB 646](#) by Rodriguez)

Establishes Sunshine Scholarship program; provides program & student requirements; provides for funding & rulemaking.

[SB 186](#) – Resign-to-run Law by Hutson (I: [HB 105](#) by Santiago)

Requiring an officer who qualifies for federal public office to resign from the office he or she presently holds if the terms, or any part thereof, run concurrently; providing for an automatic irrevocable resignation in the event of noncompliance; etc.

[SB 188](#) – Public School Transportation by Steube (S: [HB 1299](#) by Raburn)

Requiring district school boards to provide transportation to certain students; revising the speed and road conditions that meet the requirements for a hazardous walking condition; requiring a district school superintendent to request a review of a hazardous walking condition; etc.

[SB 192](#) – Public Meetings by Baxley (S: [HB 79](#) by Roth)

Specifying conditions under which members of any board or commission of any state agency or authority or of any agency or authority of any county, municipal corporation, or political subdivision may participate in fact-finding exercises or excursions, etc.

[SJR 194](#) – Limitation of Terms/School Board Members by Steube (I: [HJR 1031](#) by Fischer)

Proposing an amendment to Section 4 of Article IX of the State Constitution to limit the terms of office for a member of a district school board, etc.

[HB 207](#) – Growth Management by McClain (S: [SB 362](#) by Perry)

Requires local governments to address protection of private property rights in their comprehensive plans; requires counties & municipalities to adopt or amend land development regulations consistent with private property rights element; requires state land planning agency to approve private property rights element if it is substantially in specified form; etc.

[HB 211](#) – Crimes Evidencing Prejudice by Geller (S: [SB 588](#) by Rader)

Requires grounds for reclassification of crimes to include prejudice based on gender or gender identity of victim or based on disability of victim; revises definition of term "disability."

[SB 216](#) – Schools of Hope by Book

Revising enrollment requirements for a hope operator to receive a loan under the Schools of Hope Revolving Loan Program; requiring hope operators to employ school administrators and instructional and noninstructional personnel who meet specified certification requirements, etc.

[SB 224](#) – Legal Holidays by Book (I: [HB 277](#) by Moskowitz)

Removing the designations of the birthdays of Robert E. Lee and Jefferson Davis and Confederate Memorial Day as legal holidays;etc.

[HB 225](#) – Employment Discrimination by Davis (S: [SB 1828](#) by Rodriguez)

Prohibits employer from taking retaliatory personnel action against employee for evacuating under emergency evacuation order; provides for remedies, relief, & attorney fees & costs; etc.

[HB 227](#) – Workers' Compensation Benefits for First Responders by Willhite (I: [SB 376](#) by Book)

Deletes certain limitations relating to workers' compensation benefits for first responders; provides first responders are entitled to workers' compensation benefits for mental or nervous injuries regardless of whether such injuries are accompanied by physical injuries.

[SB 230](#) – Next Generation Sunshine State Standards by Bracy

Requiring the Commissioner of Education to propose revisions to the Next Generation Sunshine State Standards in visual and performing arts by a specified date; requiring the State Board of Education to adopt, reject, or modify any proposed revisions by a specified date, etc.

[SB 242](#) – Developmental Disabilities by Baxley (S: [HB 969](#) by Burgess)

Citing this act as the "Gabe's Act"; revising the term "developmental disability" to include the disorder and symptoms attributable to Duchenne muscular dystrophy, etc.

[HB 251](#) – Reemployment After Retirement by Clemons (I: [SB 406](#) by Steube)

Authorizes retiree of FRS to be reemployed under certain circumstances.

[SB 252](#) – State Employee Higher Education Fee Waivers by Steube (I: [HB 1371](#) by Ausley)

Providing that credit hours eligible for tuition and fee waivers be determined on a calendar year basis, rather than per academic term, etc.

[SB 260](#) – Students with Disabilities in Public Schools by Book (I: [HB 63](#) by Edwards)

Revising school district policies and procedures relating to restraint and seclusion of students with disabilities; requiring continuing education and inservice training for teaching students with emotional or behavioral disabilities, etc.

[SB 270](#) – Involuntary Examination/Admission of Minors by Steube (I: [HB 947](#) by Payne)

Authorizing a designated law enforcement agency to decline to transport a minor 14 years of age or younger to a receiving facility for mental health or substance abuse evaluation if the parent or guardian agrees to transport the minor to the receiving facility; requiring the examination of a minor 14 years of age or younger to be initiated within 8 hours after the patient's arrival at the receiving facility, etc.

[SB 272](#) – Local Tax Referenda by Brandes (I: [HB 317](#) by Ingoglia)

Revising the voter approval threshold required to pass a referendum to adopt or amend local government discretionary sales surtaxes when the referendum is held at any date other than a general election; etc.

[HB 273](#) – Public Records by Rodrigues (I: [SB 750](#) by Perry)

Prohibits agency that receives request to inspect or copy record from responding to such request by filing civil action against individual or entity making request.

[SB 274](#) – Concealed Weapons / Multiuse Facilities by Stargel (I: [HB 113](#) by Fitzenhagen)

Providing that a person licensed to carry a concealed weapon or concealed firearm is not prohibited by specified laws from such carrying on the property of certain institutions, etc.

[HB 277](#) – Legal Holidays by Moskowitz (I: [SB 224](#) by Book)

Removes designations of birthdays of Robert E. Lee & Jefferson Davis & Confederate Memorial Day as legal holidays.

[SB 294](#) – Mandatory Retention by J. Rodriguez (I: [HB 161](#) by J. Cortes)

Removing the requirement for mandatory retention of a third grade student based on his or her performance on the English Language Arts assessment, etc.

[HB 299](#) – Florida Building Commission by McClain

Revises membership of the commission; revises membership qualifications.

[SB 308](#) – Federal Immigration Enforcement by Bean (S: [HB 9](#) by Metz)

Citing this act as the “Rule of Law Adherence Act”; creating provisions relating to federal immigration enforcement; prohibiting sanctuary policies; requiring state entities, local governmental entities, and law enforcement agencies to comply with and support the enforcement of federal immigration law; etc.

[HB 309](#) – Fire Safety by Antone (I: [SB 394](#) by Bracy)

Requires Division of State Fire Marshal to establish specified courses as part of firefighter & volunteer firefighter training & certification; revises firefighter certification requirements; specifies division's authority to adopt rules for training related to cancer & mental health risks within fire service.

[SB 310](#) – Threats to Kill or do Bodily Injury by Steube (S: [HB 165](#) by McClain)

Prohibiting a person from making a threat to kill or do bodily injury to another person in a writing or other record and transmitting that threat in any manner, etc.

[HB 311](#) – Alternative High School Graduation Requirements by Massullo (I: [SB 788](#) by Montford)

Provides alternative pathways to standard high school diploma, student eligibility requirements, and requirements for meeting alternative pathways to standard high school diploma; specifies required documentation & requires district school boards to incorporate certain information in specified plan.

[HB 317](#) – Local Tax Referenda by Ingoglia (I: [SB 272](#) by Brandes)

Requires local government discretionary sales surtax referenda to be held on date of a primary or general election & requires specified percentage of votes for passage; etc.

[SB 318](#) – Internship Tax Credit Program by Powell (S: [HB 49](#) by Jones)

Creating the “Florida Internship Tax Credit Program”; authorizing a corporate income tax credit up to a specified amount to a qualified business paying wages to a degree-seeking student during the student's internship at the business; etc.

[HB 323](#) – High School Graduation Requirements by Fitzenhagen (I: [SB 88](#) by Hukill)

Revises requirements for Next Generation Sunshine State Standards to include financial literacy & required credits for a standard high school diploma to include instruction in personal financial literacy & money management.

[SB 324](#) – Impact Fees by Young (S: [HB 697](#) by Miller)

Specifying the earliest time of collection that a local government may require for impact fees, etc.

[HB 345](#) – Duty to Provide Emergency Assistance by Goodson (I: [SB 516](#) by Mayfield)

Requires person at scene of emergency to provide reasonable assistance to endangered person; provides criminal penalties; provides immunity from liability for providing reasonable assistance.

[HB 347](#) – Prohibited Discrimination by Diamond & Plasencia (S: [SB 66](#) by Rouson)

Provides that sexual orientation & gender identity are impermissible grounds for discrimination in public lodging establishments & public food service establishments; revises provisions of Florida Civil Rights Act of 1992 and Fair Housing Act to include sexual orientation & gender identity; provides exception for constitutionally protected free exercise of religion.

[SB 354](#) – Government Accountability by Stargel (S: [HB 11](#) by Metz)

Specifying that the Governor, the Commissioner of Education, or designee may notify the Legislative Auditing Committee of an entity's failure to comply with certain auditing and financial reporting requirements; prohibiting a board or commission from requiring an advance copy of testimony or comments from a member of the public as a precondition to being given the opportunity to be heard at a public meeting, etc.

[HB 361](#) – Persons Authorized to Visit Juvenile Facilities by Richardson (S: [SB 1004](#) by Brandes)

Authorizes specified persons to visit juvenile facilities operated by DJJ; prohibits other persons from visiting such facilities except according to DJJ regulations; prohibits unreasonable withholding of permission for visits by certain persons.

[SB 362](#) – Growth Management by Perry (S: [HB 207](#) by McClain)

Requiring local governments to address the protection of private property rights in their comprehensive plans; requiring the state land planning agency to approve the private property rights element adopted by each local government if it is substantially in a specified form; etc.

[SB 366](#) – Autism Awareness Week by Campbell

Designating April 1-7, 2018, as "Autism Awareness Week" in Florida, etc.

[SB 368](#) – Department of Management Services by Brandes (S: [HB 111](#) by Albritton)

Creating the Statewide Procurement Efficiency Task Force within the department; specifying the purpose and membership of the task force; providing that task force members shall serve without compensation or reimbursement of expenses; etc.

[SB 376](#) – Workers' Compensation Benefits for First Responders by Book (I: [HB 227](#) by Willhite)

Deleting certain limitations relating to workers' compensation benefits for first responders; providing that law enforcement officers, firefighters, emergency medical technicians, and paramedics are entitled to benefits under the Workers' Compensation Law for mental or nervous injuries, whether or not such injuries are accompanied by physical injuries requiring medical treatment; etc.

[HB 389](#) – Classroom Teacher and School Principal Salaries by Jones

Provides for increase in classroom teacher's & school principal's base salary for specified fiscal years; provides appropriation.

[HB 391](#) – Drug and Violence Prevention Programs by Gruters (I: [SB 802](#) by Garcia)

Requires each school district to implement drug & violence prevention program; provides purpose of program; provides program requirements & funding; authorizes SBE to adopt rules.

[HB 393](#) – Discrimination in Labor and Employment by Berman (S: [SB 594](#) by Stewart)

Prohibits employer from providing less favorable employment opportunities to employees based on sex, with exceptions; provides civil penalties & exemption; etc.

[SB 394](#) – Fire Safety by Bracy (I: [HB 309](#) by Antone)

Requiring the Division of State Fire Marshal to establish specified courses as a part of firefighter and volunteer firefighter training and certification; specifying the division's authority to adopt rules for training related to cancer and mental health risks within the fire service, etc.

[HB 399](#) – McKay Scholarship Program by Mariano (S: [SB 564](#) by Young)
Authorizes parent to request IEP meeting & reevaluation from school district for specified purposes; authorizes school district to change matrix of services for student as result of IEP reevaluation.

[HB 401](#) – Placement of Instructional Personnel by Albritton (I: [SB 930](#) by Montford)
Prohibits use of a specified student learning growth formula as only factor in determining placement of certain instructional personnel.

[SB 406](#) – Retirement by Steube (I: [HB 251](#) by Clemons)
Providing an exception to the reemployment after retirement limitations to authorize a retiree of the Florida Retirement System to be reemployed by an employer under certain circumstances, etc.

[HB 411](#) – Public Records/Firesafety Systems by Clemons (I: [SB 738](#) by Perry)
Provides exemption from public records requirements for firesafety system plans held by agency and exemption from public meetings requirements for meetings that would reveal such plans; etc.

[HB 423](#) – Higher Education by Rodrigues (I: [SB 4](#) by Galvano)
Revises preeminent state research universities program, State University System Performance-Based Incentive, requirements for specified state university direct-support organizations, & postsecondary student fees & tuition; revises & creates various scholarship programs for certain students; etc.

[HB 427](#) – Instructional Personnel and Administrator Salaries by Plasencia (S: [SB 1324](#) by Mayfield)
Authorizes district school board to use advanced degree in setting salary schedule for specified employees; authorizes rather than requires district school board to adopt performance salary schedule; authorizes rather than requires district school board to provide for specified salary supplements.

[HB 433](#) – Discrimination in Employment Screening by Henry (I: [SB 102](#) by Bracy)
Prohibits employer from inquiring into or considering applicant's criminal history on initial employment application unless otherwise required to do so by law.

[SB 436](#) – Education by Galvano
Authorizing the Commissioner of Education to coordinate with specified educational entities to assess needs for resources and assistance in the event of an emergency situation, etc.

[HB 439](#) – Public Meetings and Records by Donalds (S: [SB 560](#) by Steube)
Expands exemption from public meetings requirements to allow specified entities to meet in private with attorney to discuss imminent litigation if certain conditions are met; specifies when litigation is considered imminent; provides for future legislative review & repeal of exemption; etc.

[SB 460](#) – Postsecondary Fee Waivers by Gainer (S: [HB 75](#) by Ponder)
Authorizing a Florida College System institution to waive any portion of certain postsecondary fees for active duty members of the Armed Forces of the United States who use military tuition assistance; etc.

[HB 475](#) – Deferred Action for Childhood Arrivals Program by Jacquet (S: [SB 882](#) by Campbell)
Urges Congress to preserve Deferred Action for Childhood Arrivals (DACA) program.

[HB 489](#) – Juvenile Civil Citation and Similar Diversion Programs by Pritchett (I: [SB 644](#) by Bracy)
Requires establishment of civil citation or similar diversion programs for juveniles; specifies program eligibility, participation, & implementation requirements.

[HB 495](#) – School District Price Level Index by Diaz (I: [SB 824](#) by Garcia)
Requires DOE to issue competitive solicitation for review of current price level index methodology by specified entity; provides that competitive solicitation & review occur every 10 years; etc.

[HB 509](#) – Juvenile Justice by Shaw (S: [SB 936](#) by Powell)

Creates exception to suspension of civil rights upon conviction of felony for children convicted as adults; revises factors that court must consider when determining whether child should be transferred to adult court; authorizes, rather than requires, court to order child to be housed in adult detention facility in certain circumstances; etc.

[SB 496](#) – Out-of-School Suspension by Baxley (S: [HB 563](#) by Harrell)

Authorizing a parent to give public testimony regarding a district school board's suspension policy; requiring a district school board to review its rules authorizing suspension during a specified timeframe at a district school board meeting; requiring the board to take public testimony at the meeting; etc.

[HB 515](#) – Offenses Against Students by Authority Figures by Hahnfeldt (S: [SB 736](#) by Baxley)

Prohibits certain conduct with students by authority figures; provides exceptions.

[SB 516](#) – Duty to Provide Emergency Assistance by Mayfield (I: [HB 345](#) by Goodson)

Requiring a person at the scene of an emergency to provide reasonable assistance to an endangered person; providing a criminal penalty; providing immunity from liability for providing assistance; etc.

[SB 526](#) – Deregulation of Professions and Occupations by Bracy (S: [HB 15](#) by Beshears)

Authorizing the executive director or the chair of the board to authorize a temporary qualifying agent under certain circumstances; requiring the board to allow an applicant to qualify one or more business organizations or to operate using a fictitious name under certain circumstances; etc.

[SB 540](#) – Postsecondary Education by Hukill (S: [HB 831](#) by Gruters)

Creating the State Board of Community Colleges; revising requirements for the performance-based metrics; requiring each Florida Community College System institution and each state university to execute at least one "2+2" targeted pathway articulation agreement by a specified time; etc.

[SB 542](#) – Public Financing of Construction Projects by Rodriguez

Prohibiting state-financed constructors from commencing construction of certain structures in coastal areas without first conducting a sea level impact projection study; etc.

[HB 543](#) – Books to Babies Pilot Project by Cortes (S: [SB 1146](#) by Simmons)

Requires Office of Early Learning to establish Books to Babies Pilot Project in Seminole & Orange Counties; requires OEL to select organization to implement pilot project; etc.

[HB 545](#) – Prohibition/Contracting with Scrutinized Companies by Fine (I: [SB 780](#) by Brandes)

Prohibits company that is on Scrutinized Companies that Boycott Israel List or that is engaged in boycott of Israel from bidding on, submitting proposal for, or entering into or renewing contract with agency or local governmental entity for goods or services; provides exceptions; etc.

[SB 560](#) – Public Meetings and Records/Imminent Litigation by Steube (S: [HB 439](#) by Donalds)

Expanding an exemption from public meetings requirements to allow specified entities to meet in private with an attorney to discuss imminent litigation; requiring the transcript of a private meeting concerning imminent litigation to be made public upon the occurrence of a certain circumstance, etc.

[HB 563](#) – Out-of-School/In-School Suspension by Harrell (S: [SB 496](#) by Baxley)

Authorizes parent to give public testimony regarding district school board's out-of-school & in-school suspension policy; requires district school board to review certain suspension policies during specified timeframe at district school board meeting; provides meeting requirements & expiration of rules.

[SB 564](#) – McKay Scholarship Program by Young (S: [HB 399](#) by Mariano)

Providing that parents seeking an individual education plan reevaluation may request a specified meeting and evaluation from the school district; specifying that a school district may change a student's matrix of services as a result of an individual education plan reevaluation, etc.

[HB 565](#) – Excess Credit Hour Surcharges by Mariano (I: [SB 844](#) by Bean)

Provides exception to excess credit hour surcharge requirement for certain students; provides separate excess hour surcharge threshold for students enrolled in certain degree programs designated as area of strategic emphasis by BOG.

[HB 573](#) – Involuntary Examinations/Baker Act by Daniels (I: [SB 112](#) by Campbell)

Authorizes physician assistants & ARNPs to execute certificate under certain conditions stating that they have examined a person & find person appears to meet criteria for involuntary examination.

[HB 577](#) – High School Graduation Requirements by Silvers (I: [SB 856](#) by Montford)

Authorizes student to use credit earned upon completion of apprenticeship or pre-apprenticeship program to satisfy specified high school graduation requirements; requires SBE to approve & identify registered apprenticeship & pre-apprenticeship programs.

[SB 582](#) – Write-in Candidate Qualifying by Rader (I: [HB 6009](#) by Geller)

Repealing provisions relating to write-in candidate residency requirements; repealing a requirement that all write-in candidates must reside within the district represented by the office sought at the time of qualification, etc

[SB 586](#) – Instructional Personnel Salaries by Rader

Citing this act as the "Florida Teacher Fair Pay Act"; requiring the Legislature to fund the Florida Education Finance Program at a level that ensures certain schedules guarantee a minimum annual starting salary for instructional personnel, etc.

[HB 587](#) – Year-round School Programs by Newton (I: [SB 668](#) by Brandes)

Authorizes district school board to create year-round school program for school within its district that is one of 300 lowest-performing schools; revises intensive reading instruction options that school district with one or more of 300 lowest-performing elementary schools may use.

[SB 588](#) – Crimes Evidencing Prejudice by Rader (S: [HB 211](#) by Geller)

Expanding grounds for the reclassification of crimes to include prejudice based on the gender or gender identity of the victim and/or a disability of the victim; etc.

[HB 589](#) – Public Meetings by Newton (S: [SB 1092](#) by Rader)

Specifies that certain boards and commissions are subject to public meetings requirements; revises notice requirements; provides that member of public has right to speak at public meeting; requires members of board or commission to respond to questions made at public meetings within a specified timeframe; repeals provision relating to reasonable opportunity to be heard at public meetings; etc.

[HB 591](#) – Missing Persons With Special Needs by Porter (S: [SB 1156](#) by Perry)

Expands pilot projects for missing persons with special needs to all centers for autism & related disabilities at institutions in state university system.

[SB 594](#) – Discrimination in Labor and Employment by Stewart (S: [HB 393](#) by Berman)

Prohibiting an employer from providing less favorable employment opportunities to employees based on their sex; prohibiting an employer from taking certain employment actions against employees; prohibiting an employer from engaging in certain activities relating to employee wages and benefits or requiring employees to sign certain waivers and documents; etc.

[SB 600](#) – Florida Bright Futures Scholarship Program by Campbell
Revising the criteria for renewal of Florida Bright Futures Scholarship Program awards to include a minimum number of volunteer service work hours; providing an exception for a student who enlists in military service, etc.

[SB 604](#) – Actions Against Contractors/Required Insurance Coverage by Steube (I: [HB 89](#) by Spano)
Providing that a contractor who fails to carry required insurance may be personally liable for damages that would have been covered by such insurance, etc.

[SB 608](#) – Public Records/Identity Theft and Fraud Protection Act by Passidomo
Requiring an agency to review for information susceptible to use for purposes of identity theft or fraud before making postings to a publicly available website; requiring an agency to establish a policy providing for requests to remove an image or a copy of a public record containing information susceptible to use for purposes of identity theft and fraud, etc.

[HB 611](#) – Regional Agency/Regional Planning Council Meetings by Geller (I: [SB 1380](#) by Rodriguez)
Provides requirements for establishing quorum for meetings of certain agencies & councils when voting member appears via telephone, real-time videoconferencing, or similar real-time electronic or video communication; requires notice of intent to appear via telephone, real-time videoconferencing, or similar real-time electronic or video communication by specified time.

[SB 614](#) – Participant Local Government Advisory Council by Montford (I: [HB 6003](#) by White)
Abolishing the Participant Local Government Advisory Council, etc.

[HB 621](#) – School Safety by Rommel (I: [SB 1236](#) by Baxley)
Provides exception to prohibition on possessing firearms & specified devices on school property for authorized concealed weapon & firearm licensees who are designated by school principals & district school superintendents; provides requirements for designees; requires district school boards to formulate & prescribe policies & procedures for active shooter & hostage situations; requires that active shooter training for each school be conducted by law enforcement agency designated as first responders to school's campus; requires district school superintendents to provide recommendations on school safety & security to law enforcement agencies; etc.

[HB 629](#) – Workers' Compensation/First Responders by Asencio (I: [SB 126](#) by Torres)
Revises burden of proof to demonstrate mental or nervous injury involving first responders for workers' compensation claims; provides that benefits may be paid even if there is no physical injury.

[SB 644](#) – Juvenile Civil Citation and Similar Diversion Programs by Bracy (I: [HB 489](#) by Pritchett)
Requiring the establishment of civil citation or similar diversion programs for juveniles; specifying program eligibility, participation, and implementation requirements, etc.

[SB 646](#) – Sunshine Scholarship Program by Rodriguez (S: [HB 181](#) by Jones; [SB 794](#) by Braynon)
Establishing the Sunshine Scholarship Program for specified purposes; requiring the Department of Education to administer the program; providing for funding, etc.

[SB 648](#) – Employment Services for Persons with Disabilities by Baxley (I: [HB 1437](#) by Abruzzo)
Specifying that participants in certain disabled persons' work experience activities are considered state employees for workers' compensation purposes; etc.

[SB 650](#) – Administrative Review of Property Taxes by Baxley
Providing that under certain circumstances, petitions to the value adjustment board may be late filed within a specified timeframe, subject to certain limitations, etc.

[SB 654](#) – Early Childhood Music Education Incentive Pilot Program by Perry
Extending the scheduled expiration of the pilot program; providing an appropriation; etc.

[HB 663](#) – Students Remaining on School Grounds by Slosberg (S: [SB 682](#) by Garcia)
Authorizes district school boards to adopt policies permitting students to leave school grounds during lunch period; prohibits schools in certain districts from permitting students to leave school grounds during lunch period without prior written parental consent.

[HB 665](#) – Retirement by Clemons (I: [SB 772](#) by Garcia)
Specifies minimum amount of the factor used to calculate the cost-of-living adjustment of benefits for certain retirees & beneficiaries of the Florida Retirement System; etc.

[SB 668](#) – Year-round School Programs by Brandes (I: [HB 587](#) by Newton)
Authorizing a district school board to create a year-round school program for any school within its district that is one of the 300 lowest-performing schools in the state; authorizing a specified number of hours in a summer program or a year-round school program, etc.

[SB 680](#) – Construction Defect Claims by Passidomo (S: [HB 759](#) by Trumbull)
Providing additional requirements for notices of claim, inspections, and notices of acceptance or rejection of settlement offers; providing that an authorized representative of a claimant may act on the behalf of the claimant if the claimant is a business entity; etc.

[SB 682](#) – Students Remaining On School Grounds by Garcia (S: [HB 663](#) by Slosberg)
Providing that a district school board may adopt policies for releasing students for the school lunch period; requiring schools in certain districts to obtain written parental consent before permitting students to leave school grounds during the lunch period.

[SB 686](#) – Tax on Sales, Use, and Other Transactions by Perry
Providing an exemption from the sales and use tax for the sale of certain clothing, wallets, bags, school supplies, and personal computers and related accessories during a specified period; providing exceptions to the exemption, etc.

[SB 696](#) – Conversion Therapy by Rodriguez (I: [HB 717](#) by Jenne)
Prohibiting a person who is licensed to provide professional counseling or a practitioner who is licensed under provisions regulating the practice of medicine, osteopathic medicine, psychology, clinical social work, marriage and family therapy, or mental health counseling from practicing or performing conversion therapy with an individual who is younger than a specified age; etc.

[HB 697](#) – Impact Fees by Miller (S: [SB 324](#) by Young)
Prohibits collection of impact fees by a local government earlier than a specified time.

[HB 699](#) – Enrollment/Children of Military Personnel in FLVS by Killebrew (I: [SB 1090](#) by Young)
Requires FLVS to give enrollment priority to certain dependent children of active duty military personnel; authorizes FLVS to use specified form to determine residence & to serve specified students directly; provides funding for such students.

[HB 711](#) – Preapprenticeship and Apprenticeship Programs by Asencio (S: [SB 1388](#) by Garcia)
Creates Earn & Learn Grant Program within DOE; provides definitions & department responsibilities; provides requirements for preapprenticeship & apprenticeship programs receiving grant funds; establishes Task Force on Apprenticeship Expansion within DEO; requires task force to submit report to Governor & Legislature by specified date; provides appropriations; etc.

[HB 715](#) – Purchases of Tangible Personal Property by Contractors by Leek (S: [SB 1108](#) by Young)
Authorizes governmental entities to allow specified entities to use its certificate of entitlement of exemption for certain tangible personal property; provides procedures for allowing such use; requires letter of authorization to specify issues regarding risk of damage or loss of property.

[HB 717](#) – Conversion Therapy by Jenne (I: [SB 696](#) by Rodriguez)
Defines "conversion therapy"; prohibits person who is licensed to provide professional counseling or practitioner who is licensed under provisions regulating practice of medicine, osteopathic medicine, psychology, clinical social work, marriage & family therapy, or mental health counseling from practicing or performing conversion therapy with an individual who is younger than specified age; etc.

[SB 722](#) – Retirement by Garcia (I: [HB 665](#) by Clemons)
Specifying the minimum amount of the factor used to calculate the cost-of-living adjustment of benefits for certain retirees and beneficiaries of the Florida Retirement System, etc.

[HB 731](#) – Home Education by Sullivan (S: [SB 732](#) by Baxley)
Revises provisions relating to home education programs, school attendance requirements, home education student participation in interscholastic and intrascholastic extracurricular student activities & dual enrollment programs.

[SB 732](#) – Home Education by Baxley (S: [HB 731](#) by Sullivan)
Specifying that a home education program is not a school district program and is registered with the district school superintendent only for the purpose of complying with the state's attendance requirements; authorizing a school district to provide home education program students with access to certain courses and programs offered by the school district; prohibiting a district school superintendent from requiring certain evidence relating to a child's age from children enrolled in specified schools and programs, etc.

[SB 736](#) – Prohibited Conduct/Authority Figures and Students by Baxley (S: [HB 515](#) by Hahnfeldt)
Defining terms; prohibiting an authority figure from soliciting or engaging in sexual conduct or a romantic relationship with a student; prohibiting an authority figure from soliciting or engaging in lewd conduct with a student; providing a criminal penalty, etc.

[SB 738](#) – Public Records/Firesafety System Plans by Perry (I: [HB 411](#) by Clemons)
Providing an exemption from public records and public meetings requirements for information relating to firesafety systems for certain properties and meetings relating to such systems and information; etc.

[HB 739](#) – Carrying of Weapons and Firearms by Fant (I: [SB 1242](#) by Steube)
Provides specified provisions relating to carrying of weapons & firearms do not apply to persons engaged in, traveling to, or returning from certain outdoor activities or traveling to or returning from certain motor vehicles, residences, shelters, & other places.

[SB 750](#) – Public Records by Perry (I: [HB 273](#) by Rodrigues)
Prohibiting an agency that receives a request to inspect or copy a record from responding to such request by filing a civil action against the individual or entity making the request, etc.

[HB 757](#) – The Teacher Scholarship Program by Massullo (S: [SB 944](#) by Montford)
Establishes Teacher Scholarship Program within DOE; provides program purpose & requirements; provides for rulemaking.

[HB 759](#) – Construction Defect Claims by Trumbull (S: [SB 680](#) by Passidomo)
Provides additional requirements for notices of claim, inspections, and notices of acceptance or rejection of settlement offers; etc.

[HB 767](#) – Pay-For-Success Contracts by Ausley (S: [SB 1084](#) by Rouson)

Authorizes state agency to enter into pay-for-success contract with private entity subject to appropriation; specifies services & programs that may be eligible for funding under contract; requires agency to provide annual report to legislative appropriations committees; etc.

[HB 769](#) – Florida Security for Public Deposits Act by Trumbull (S: [SB 1258](#) by Hutson)

Specifies information to be included in financing agreements; requires local governments to provide certain disclosures in finance agreements; requires lenders to include certain disclosures in loan agreements; revises terms applicable to Florida Security for Public Deposits Act to add credit unions to list of entities that may qualify as "qualified public depository"; etc..

[HB 777](#) – K-12 Student Safety by Moskowitz (S: [SB 1548](#) by Book)

Revises provisions relating to Level 2 background screenings, district school board duties, examination security, recension of student certificates & grades, school district employment criteria, educator certification, certified educator responsibilities, & Education Practices Commission.

[HB 779](#) – Education Facilities as Emergency Shelters by Cruz (I: [SB 1556](#) by Rodriguez)

Requires education facilities that have received public education capital outlay funding be made available to county & state emergency management offices during state of emergency; etc.

[SB 780](#) – Prohibition/Contracting with Scrutinized Companies by Brandes (I: [HB 545](#) by Fine)

Prohibiting a company that is on the Scrutinized Companies that Boycott Israel List or that is engaged in a boycott of Israel from bidding on, submitting a proposal for, or entering into or renewing a contract with an agency or local governmental entity for goods or services of any amount; etc.

[SB 788](#) – Alternative High School Graduation Requirements by Montford (I: [HB 311](#) by Massullo)

Providing that certain students are eligible for alternative pathways to a standard high school diploma; requiring district school boards to incorporate certain information in the student progression plan; etc.

[SB 794](#) – Sunshine Scholarship Program by Braynon (S: [HB 181](#) by Jones; [SB 646](#) by Rodriguez)

Establishing the Sunshine Scholarship Program for specified purposes; requiring the Department of Education to administer the program; etc.

[HB 795](#) – Cardiopulmonary Resuscitation in Public Schools by Altman (I: [SB 996](#) by Mayfield)

Requires school districts to provide instruction in cardiopulmonary resuscitation & use of automated external defibrillator; provides student & instruction requirements; provides exemption.

[SB 798](#) – Background Screening by Braynon (I: [HB 1223](#) by McGhee)

Prohibiting employers from excluding an applicant from an initial interview for employment under certain conditions; requiring the Department of Economic Opportunity to enforce the act, etc.

[SB 802](#) – Drug and Violence Prevention Programs by Garcia (I: [HB 391](#) by Gruters)

Requiring each school district to implement a drug and violence prevention program by a specified school year for certain students; etc.

[HB 807](#) – Metropolitan Planning Organizations by Diamond (S: [SB 984](#) by Brandes)

Provides voting membership requirements for certain metropolitan planning organizations designated on or after specified date.

[HB 815](#) – County and Municipal Public Officers and Employees by Avila (S: [SB 1180](#) by Steube)

Requires that request to travel outside of state by county & municipal public officers be approved by governing board; prohibits travel expenses for foreign travel; limits lodging expenses; requires public officers who are candidates for elected office to make campaign finance reports available online; etc.

[SB 824](#) – School District Price Level Index by Garcia (I: [HB 495](#) by Diaz)

Requiring the Department of Education to issue a competitive solicitation for the review of the current price level index methodology by a specified entity; requiring a report of recommendations be provided to the chair of the Senate Committee on Appropriations, the chair of the House of Representatives Appropriations Committee, and the Executive Office of the Governor's Office of Policy and Budget; providing that the competitive solicitation and review occur every 10 years; etc.

[HB 825](#) – Educational Standards For K-12 Public Schools by Stone (S: [SB 966](#) by Baxley)

Revises Next Generation Sunshine State Standards; provides that NGSSS are minimum baseline core content standards for K-12 public schools; requires each school district to adopt standards equivalent to or better than NGSSS; revises content requirements for such standards; revises requirements for certain instructional materials.

[HB 827](#) – Instructional Materials by Donalds (C: [SB 1644](#) by Lee)

Revises provisions relating to review & adoption of instructional materials.

[HB 829](#) – The McKay Scholarships by Plasencia (I: [SB 1080](#) by Baxley)

Provides that specified eligibility requirements do not apply to students in certain grades beginning in specified school year; revises student eligibility criteria; provides for calculation of scholarship amount for students diagnosed by physicians or psychologists; provides for adjustment of scholarship amount.

[HB 831](#) – Postsecondary Education by Gruters (S: [SB 540](#) by Hukill)

Creates State Board of Community Colleges; revises function & mission of Florida K-20 education system; revises provisions relating to postsecondary education.

[SB 832](#) – Funds for the Education of Inmates by Farmer

Removing a provision prohibiting state funds for the operation of postsecondary workforce programs from being used for the education of state or federal inmates, etc.

[HB 839](#) – Display of the State Motto by Daniels (I: [SB 1158](#) by Perry)

Requires each district school board to adopt rules for display of official state motto in specified places.

[HB 843](#) – Statewide Item Bank for Local Assessments by Bileca

Removes provision authorizing Commissioner of Education to discontinue statewide item bank; requires certain assessment items to be included in item bank.

[SB 844](#) – Excess Credit Hour Surcharges by Bean (I: [HB 565](#) by Mariano)

Providing an exception to the excess credit hour surcharge requirement for certain students; providing a separate excess hour surcharge threshold for students enrolled in certain degree programs; etc.

[HB 845](#) – Professional Development for the School Community by Bileca

Requires web-based statewide performance-support system provided by DOE to include sample course-at-a-glance & unit overview templates; provides requirements for such resources.

[SB 856](#) – High School Graduation Requirements by Montford (I: [HB 577](#) by Silvers)

Authorizing the use of credits earned upon completion of a registered apprenticeship or preapprenticeship to satisfy specified high school graduation credit requirements, etc.

[SB 858](#) – Daylight Saving Time by Steube (S: [HB 1013](#) by Nunez)

Exempting the State of Florida and its political subdivisions from daylight saving time; requiring that the state and all of its political subdivisions observe standard time, etc.

[SB 860](#) – Criminal History Records by Bracy (I: [HB 919](#) by Brown)

Requiring the Criminal Justice Information Program to administratively seal the criminal history records of a minor under specified circumstances, etc. [Linked to [SB 862](#) providing a public records provision.]

[HB 871](#) – Government Actions Discriminating Against Businesses by Fant (I: [SB 1290](#) by Baxley)

Designates act "Free Enterprise Protection Act"; prohibits discriminatory actions by governmental entities against business entities.

[SM 882](#) – Deferred Action for Childhood Arrivals Program by Campbell (S: [HM 475](#) by Jacquet)

Urging Congress to preserve the Deferred Action for Childhood Arrivals Program, etc.

[HB 887](#) – Reading Instruction by Harrell (I: [SB 1306](#) by Perry)

Requires certain plans to provide for certain reading interventions that meet certain criteria beginning with specified school year; requires DOE to consider award of endorsements for teaching certificate; requires school districts to provide access to training sufficient to earn endorsement in reading.

[HB 909](#) – Free Expression on Campus by Rommel (S: [SB 1234](#) by Baxley)

Authorizes public institution of higher education to create & enforce restrictions on expressive activities on campus; provides cause of action for violation of act; provides for specific damages; etc.

[SB 912](#) – Agency Rulemaking by Broxson (S: [HB 83](#) by Spano)

Requiring certain notices to include an agency website address for a specified purpose; requiring the Department of State to include on the Florida Administrative Register website the agency website addresses where statements of estimated regulatory costs can be viewed in their entirety; etc.

[HB 919](#) – Criminal History Records by Brown (I: [SB 860](#) by Bracy)

Requires Criminal Justice Information Program to administratively seal criminal history records of minor upon notification by clerk of court. [Linked to [HB 921](#) providing a public records provision.]

[HB 925](#) – Disclosure of Financial Interests/Charter Schools by Newton (S: [SB 1266](#) by Thurston)

Provides financial disclosure requirements for charter school employees; etc.

[SB 930](#) – Placement of Instructional Personnel by Montford (I: [HB 401](#) by Albritton)

Prohibiting the use of a specified student learning growth formula as the only factor in determining the placement of certain instructional personnel; etc.

[SB 936](#) – Juvenile Justice by Powell (S: [HB 509](#) by Shaw)

Creating an exception to the suspension of civil rights upon the conviction of a felony for children convicted as adults; requiring children of certain ages who are convicted and sentenced to the Department of Corrections to be kept completely separated from adult offenders in the facility; etc.

[SB 944](#) – Teacher Scholarship Program by Montford (S: [HB 757](#) by Massullo)

Establishing the Teacher Scholarship Program within the Department of Education; providing a purpose of, and the criteria for, student eligibility for the program; etc.

[HB 947](#) – Involuntary Examination/Admission of Minors by Payne (I: [SB 270](#) by Steube)

Authorizes designated law enforcement agency to decline to transport minor 14 years of age or younger for mental health or substance abuse evaluation in certain circumstances; requires examination of minor to be initiated within 8 hours after patient's arrival at receiving facility; etc.

[HB 949](#) – Virtual Education by Fischer (S: [SB 1198](#) by Baxley)

Revises definition of "full-time equivalent student" & provisions relating to Florida Virtual School, virtual instruction program provider contracts, & required background screenings for specified personnel.

[HB 951](#) – Education/Early Learning/VPK by Fischer (S: [SB 1192](#) by Stargel)

Requires certain assessment results be provided to parents within specified timeframe; requires OEL to aggregate assessment results to be distributed & posted on office's website; authorizes certain students to reenroll in VPK; provides funding & criteria & procedures for reenrollment.

[SB 966](#) – Educational Standards for K-12 Public Schools by Baxley (S: [HB 825](#) by Stone)

Revising the Next Generation Sunshine State Standards; providing that such standards are the minimum baseline core content standards for K-12 public schools; revising the requirements for instructional materials that a district school superintendent annually certifies, etc.

[SB 968](#) – Mastery-based Education by Brandes (S: [HB 1035](#) by Sullivan)

Authorizing a district school board participating in the Mastery-Based Education Pilot Program to award credit based on student mastery of certain content and skills; renaming the Competency-Based Education Pilot Program as the Mastery-Based Education Pilot Program; requiring the statewide articulation agreement; etc.

[HB 969](#) – Developmental Disabilities by Burgess (S: [SB 242](#) by Baxley)

Cites act as "Gabe's Act"; revises term "developmental disability" to include disorder & symptoms attributable to Duchenne muscular dystrophy.

[HB 975](#) – Education by Grant (I: [SB 118](#) by Hukill)

Authorizes member of State Legislature to visit district school in his or her legislative district.

[HB 977](#) – Retirement of Instructional and Administrative Personnel by Fine (I: [SB 1240](#) by Mayfield)

Revises limitations on maximum length of participation in DROP for certain instructional personnel & administrative personnel; requires employer to notify Division of Retirement of DMS regarding any change in termination date & program participation for each affected member.

[SJR 978](#) – Percentage of Votes/Approval an Amendment by Baxley (I: [HJR 65](#) by Roth)

Proposing an amendment to the State Constitution to increase the percentage of elector votes required to approve an amendment or a revision to the State Constitution from 60% to 66 and 2/3%; etc.

[SB 984](#) – Metropolitan Planning Organizations by Brandes (S: [HB 807](#) by Diamond)

Requiring the voting membership of a metropolitan planning organization that is designated before a specified date to consist of a certain number of apportioned members; requiring the voting membership designated on or after a specified date as a result of a combination or merger of previously separate M.P.O.'s to consist of a certain number of members, subject to certain requirements; etc.

[SB 986](#) – Medical Use of Marijuana in Schools by Montford (S: [HB 1291](#) by Drake)

Authorizing a qualified patient to designate more than one caregiver to assist with the medical use of marijuana under certain circumstances; providing a procedure for a parent of a student to request that marijuana be administered to the student during the school day; prohibiting marijuana and marijuana delivery devices from being stored on school grounds; etc.

[SB 996](#) – Cardiopulmonary Resuscitation in Public Schools by Mayfield (I: [HB 795](#) by Altman)

Requiring school districts to provide instruction in cardiopulmonary resuscitation (CPR) and the use of an automated external defibrillator; requiring students to study and practice psychomotor skills associated with CPR at least once before graduating from high school, etc.

[SB 1004](#) – Persons Authorized to Visit Juvenile Facilities by Brandes (S: [HB 361](#) by Richardson)

Authorizing specified persons to visit, during certain hours, all state facilities housing juveniles which are operated or overseen by the Department of Juvenile Justice; prohibiting the department from unreasonably withholding permission for visits to such facilities by certain persons, etc.

[SB 1006](#) – Disaster Response and Preparedness by Montford (I: [HB 1443](#) by Alexander)
Modifying requirements for the state comprehensive emergency management plan and statewide public awareness programs administered by the Division of Emergency Management; authorizing any individual to bring a service animal or comfort animal to a special needs shelter; requiring Florida College System institutions and state universities that provide transportation assistance to coordinate the use of vehicles and personnel with local emergency management agencies, etc.

[HB 1013](#) – Daylight Saving Time by Nunez (S: [SB 858](#) by Steube)
Provides legislative intent regarding State of Florida & its political subdivisions observing daylight saving time year-round under certain conditions.

[HB 1019](#) – Financial Reporting by La Rosa
Requires counties, municipalities, special districts, water management districts, & district school boards to submit certain budget & financial information to specified entities; requires certain budget information to remain posted on such entity's official website for specified period of time; requires Office of Economic & Demographic Research to develop forms for reporting certain budget information; etc.

[HB 1023](#) – Public Educational Facilities by Duran (S: [SB 1656](#) by Lee)
Provides requirements for determining capacity of facilities in certain schools as reported in Florida Inventory of School Houses; requires Commissioner of Education to grant exemption from State Requirements for Educational Facilities to district school board under certain circumstances.

[HB 1029](#) – Tobacco Products by Hahnfeldt and Berman (S: [SB 1288](#) by Simmons)
Removes tobacco offenses from driver license penalties for persons under age 18; revises age for smoking near school property; revises prohibited age related to sale, delivery, gift, possession, & purchase of tobacco products; provides & revises penalties; revises provisions relating to restrictions on sale & delivery of nicotine products & nicotine dispensing devices; etc.

[HJR 1031](#) – Limitation of Terms/School Board Members by Fischer (I: [SJR 194](#) by Steube)
Proposes amendment to Section 4 of Article IX of State Constitution to limit terms of office for member of district school board.

[HB 1035](#) – Personalized Education by Sullivan (S: [SB 968](#) by Brandes)
Authorizes certain district school boards to award credit based on student mastery of standards & use an alternative interpretation of letter grades; renames Competency-Based Education Pilot Program as Mastery-Based Education Pilot Program; authorizes all school districts to apply to participate; requires statewide articulation agreement to include certain provisions for specified students; etc.

[SB 1036](#) – Labor Organizations by Steube (I: [HB 25](#) by Plakon)
Revising the information required to be included in an application for renewal of registration of an employee organization; providing for the revocation of certification under certain conditions; requiring certain employee organizations to recertify as bargaining agents, etc.

[HB 1045](#) – Immunization Registry by Pigman (S: [SB 1680](#) by Montford)
Revises provisions relating to communicable disease prevention & control programs under DOH; provides requirements for electronic availability of immunization records; requires certain health care practitioners to submit & update data in immunization registry; revises school-entry health requirements to require students to have certificate of immunization on file with immunization registry; etc.

[SB 1048](#) – Firearms by Baxley (S: [HB 1419](#) by McClure)
Authorizing a church, a synagogue, or other religious institution to allow a concealed weapons or concealed firearms licensee to carry a firearm on the property of the church, synagogue, or religious institution for certain purposes, etc.

[SB 1056](#) – Computer Coding Instruction by Passidomo (S: [HB 1213](#) by Porter)

Requiring a school district to provide student access to computer coding courses under certain circumstances; excluding charter schools from such requirements; providing for educator professional development and bonuses under certain circumstances, etc.

[SB 1064](#) – Dual Enrollment Programs by Baxley

Revising the contents of a postsecondary institution and private school dual enrollment articulation agreement; etc.

[SB 1074](#) – Equity In School-level Funding by Thurston (I: [HB 1157](#) by Watson)

Revising the types of funds school districts may withhold before allocating certain Title I funds to eligible schools, etc.

[SB 1080](#) – McKay Scholarships for Students with Disabilities by Baxley (I: [HB 829](#) by Plasencia)

Providing that specified eligibility requirements do not apply to students in certain grades beginning in a specified school year; revising student eligibility criteria; providing for the calculation of the scholarship amount for students diagnosed with a disability by certain physicians or psychologists; providing for the adjustment of the scholarship amount under certain circumstances, etc.

[SB 1084](#) – Pay-for-success Contracts by Rouson (S: [HB 767](#) by Ausley)

Authorizing a state agency to enter into a pay-for-success contract with a private entity under certain conditions and subject to an appropriation; specifying services and programs that are eligible for funding under a pay-for-success contract; prohibiting a private entity from viewing or receiving certain information that is otherwise confidential and exempt from public records requirements; etc.

[HB 1087](#) – Disaster Recovery Services Contracts by Watson (I: [SB 1456](#) by Garcia)

Authorizes political subdivision to add additional contractors to specified contracts for disaster recovery services for declared state of emergency; provides requirements for advertising & announcing of new or additional contractors; requiring contracts to comply with applicable federal public disaster assistance program requirements.

[SB 1090](#) – Enrollment/Children of Military Personnel/FLVS by Young (I: [HB 699](#) by Killebrew)

Requiring the Florida Virtual School to give enrollment priority to dependent children of certain active duty military personnel; authorizing the Florida Virtual School to use a specified form to determine residency and to serve specified students directly; requiring that certain dependent children of active duty military personnel be given first preference for admission to the Florida Virtual School, etc.

[HB 1091](#) – Early Learning by Grall (S: [SB 1254](#) by Passidomo)

Revises provisions relating to the Office of Early Learning, Early Learning Coalitions, & school readiness program.

[SB 1092](#) – Public Meetings by Rader (S: [HB 589](#) by Newton)

Specifying that a board or commission of any entity created by general or special law is subject to public meetings requirements; providing that a member of the public has the right to speak at a public meeting of a board or commission; repealing provisions relating to the reasonable opportunity to be heard at public meetings; etc.

[SB 1108](#) – Sales Tax Exemption for Political Subdivisions by Young (S: [HB 715](#) by Leek)

Providing that for sales of tangible personal property that will go into or become a part of public works owned by certain governmental entities, the governmental entity may authorize contractors or subcontractors to utilize the governmental entity's certificate of entitlement to the exemption for the direct purchase of the tangible personal property; etc.

[SB 1116](#) – Emergency Alerts by Simmons

Authorizing a local law enforcement agency to activate the Emergency Alert System and issue a Lockdown Alert to public and private schools and child care facilities under certain circumstances; etc.

[HB 1129](#) – Licensure of Child Care Programs by Cortes (S: [SB 1520](#) by Hutson)

Requires certain organizations providing after-school child care programs to be licensed as child care facilities.

[HB 1131](#) – Sovereign Immunity by Jenne (S: [SB 1812](#) by Rader)

Authorizes political subdivisions to insure for certain amounts to pay certain claims or judgments; prohibits payments in excess of such insurance limits from such political subdivisions; provides remedy against insurers who act in bad faith; authorizes counties to purchase umbrella policies to insure certain municipalities; authorizes parties to pursue judgments in excess of policy limits; etc.

[HB 1135](#) – School Improvement by Ausley (S: [SB 1334](#) by Baxley)

Revises requirements for school improvement plans & interventions & supports for schools in need of improvement; requires certain schools to establish early childhood transition team; provides requirements for such teams.

[SB 1146](#) – Books to Babies Pilot Project by Simmons (S: [HB 543](#) by Cortes)

Requiring the Office of Early Learning to establish the Books to Babies Pilot Project in Seminole and Orange Counties to provide resources to parents relating to emergent literacy skills; requiring OEL to select an organization to implement the pilot project; etc.

[SB 1150](#) – School Readiness Program Funding by Steube

Requiring the Office of Early Learning to develop a formula for the allocation of funding for the school readiness program which meets certain requirements; authorizing the office to adjust certain allocations for specified purposes; etc.

[HB 1151](#) – Developments of Regional Impact by La Rosa (I: [SB 1244](#) by Lee)

Repeals, creates, and revises provisions for statewide guidelines, standards, & requirements for developments of regional impact relating to authorizations to develop; applications for approval of development; concurrent plan amendments; preliminary development agreements; agency reviews; local notice & regional reports; developments inside & outside areas of critical state concern; local government development orders; construction of mitigation facilities; impact fee & exaction credits; etc.

[SB 1152](#) – School-level Funding by Garcia (I: [HB 1431](#) by Russell)

Revising the types of funds school districts may withhold before allocating certain Title I funds to eligible schools; etc.

[SB 1156](#) – Missing Persons with Special Needs by Perry (S: [HB 591](#) by Porter)

Expanding pilot projects for missing persons with special needs to all centers for autism and related disabilities at institutions in the State University System; etc.

[HB 1157](#) – Equity In School-level Funding by Watson (I: [SB 1074](#) by Thurston)

Revises types of funds school districts may withhold before allocating certain Title I funds to eligible schools.

[SB 1158](#) – Display of the State Motto by Perry (I: [HB 839](#) by Daniels)

Requiring each district school board to adopt rules for the display of the official state motto in specified places; etc.

[SB 1172](#) – Hope Scholarship Program by Galvano (I: [HB 1](#) by Donalds)

Establishing the Hope Scholarship Program; providing Department of Education obligations relating to participating students and private schools and program requirements; authorizing certain persons to elect to direct certain state sales and use tax revenue to be transferred to a nonprofit scholarship-funding organization for the Hope Scholarship Program; etc.

[HB 1175](#) – Early Learning Coalitions by Sullivan (I: [SB 1532](#) by Stargel)

Authorizes early learning coalition to refuse to contract with certain school readiness program providers.

[SB 1180](#) – County and Municipal Public Officers and Employees by Steube (S: [HB 815](#) by Avila)

Requiring elected county or municipal public officers who are candidates for elective office to make certain campaign finance reports available for posting on their county or municipal websites; etc.

[HB 1191](#) – Military and Veteran Support by Latvala (S: [SB 1566](#) by Grimsley)

Requires DVA to contract with individuals & entities to provide alternative treatment to certain veterans; requires treatment to be provided under direction of licensed individuals; requires DOE to expedite application for educator certification submitted by spouse of servicemember; requires SBE to adopt rules for extending validity of temporary certificate of spouse of servicemember; etc.

[SB 1192](#) – Education/Early Learning/VPK by Stargel (S: [HB 951](#) by Fischer)

Requiring certain assessment results to be provided to parents within a specified timeframe; authorizing certain students to reenroll in the Voluntary Prekindergarten Education Program; etc.

[HB 1197](#) – Prearrest Diversion Programs by Ahern (S: [SB 1392](#) by Brandes)

Encourages local prearrest diversion programs for certain adult offenders; requires FDLE to adopt rules to provide for expunction of certain nonjudicial records of arrest of minor upon successful completion of certain diversion programs; authorizes such expunctions for certain first-time misdemeanor offenses; requires diversion program to submit specified data to DJJ; etc. [Linked to [HB 1199](#) providing a public records exemption]

[SB 1198](#) – Virtual Education by Baxley (S: [HB 949](#) by Fischer)

Requiring the Florida Virtual School to give enrollment priority to dependent children of certain active duty military personnel; requiring that certain examinations and assessments be available to all Florida Virtual School students; etc.

[HB 1201](#) – Education For Prisoners by Ahern (S: [SB 1318](#) by Rouson)

Authorizes DOC to contract with certain entities to provide education services for Correctional Education Program; authorizes each county to contract with certain entities to provide education services for county inmates; authorizes use of state funds for operation of postsecondary workforce programs for education of certain state inmates.

[HB 1209](#) – The Florida Retirement System by Asencio (I: [SB 1692](#) by Torres)

Revises definition of "normal retirement date"; revises provisions related to early retirement benefit calculation, deferred retirement option program, benefit commencement age, & years of service to conform to changes made by act; provides declaration of important state interest.

[HB 1213](#) – Computer Science Instruction by Porter (S: [SB 1056](#) by Passidomo)

Provides requirements for specified instruction relating to computer science; requires certain computer science courses to be included in Course Code Directory & published on DOE's website by specified date; provides funds for school districts to provide professional development for classroom teachers; authorizes bonuses for certain classroom teachers; authorizes funding for high-need technology grants for school districts.

[SB 1214](#) – Child Exploitation by Book (S: [HB 7017](#) by Criminal Justice)

Revising the types of offenses committed by a child in certain custody or supervision of the Department of Children and Families which require DCF to provide notice to the school superintendent; revising the offenses for which a criminal defendant may seek an order of disclosure for certain confidential and exempt court records, for which the state may use a pseudonym instead of the victim's name, and for which a publication or broadcast of trial testimony may not include certain victim identifying information; etc. [Linked to [SB 1216](#) providing a public record exemption.]

[HB 1217](#) – Deployed Parent Custody and Visitation by Metz (I: [SB 1598](#) by Passidomo)

Creates "Uniform Deployed Parents Custody & Visitation Act"; provides requirements for granting temporary custody of child of deploying parent; provides for termination of grant; authorizes court to grant & terminate custodial orders.

[HB 1223](#) – Background Screening by McGhee (I: [SB 798](#) by Braynon)

Prohibits employers from excluding applicants from initial interviews for employment under certain conditions; provides applicability & exceptions; requires DEO to enforce act.

[HB 1233](#) – Sexual Harassment by Jacobs (S: [SB 1628](#) by Book)

Creates Task Force on the Prevention of Sexual Harassment and Misconduct; provides for task force membership, duties, responsibilities, & per diem; prohibits public officers, qualified candidates, agency employees, & lobbyists from sexually harassing individuals; provides penalties for lobbyists who violate prohibition against sexual harassment; requires Commission on Ethics to report to Governor & Cabinet, or Legislature upon violations of act.

[SB 1234](#) – Free Expression on Campus by Baxley (S: [HB 909](#) by Rommel)

Citing this act as the "Campus Free Expression Act"; Authorizing a public institution of higher education to create and enforce certain restrictions relating to expressive activities on campus; providing for a cause of action against a public institution of higher education for violations of the act, etc.

[SB 1236](#) – School Safety by Baxley (I: [HB 621](#) by Rommel)

Providing an exception to a prohibition on possessing firearms or other specified devices on school property or other specified areas for authorized concealed weapon or firearm licensees who are designated by school principals or district school superintendents; requiring district school boards to formulate and prescribe policies and procedures for active shooter and hostage situations; requiring a district school superintendent to provide specified agencies with certain strategy and activity recommendations to improve school safety and security, etc.

[SB 1240](#) – Retirement of Instructional and Administrative Personnel by Mayfield (I: [HB 977](#) by Fine)

Revising limitations on the maximum length of participation in the Deferred Retirement Option Program for certain personnel; requiring an employer to notify the Division of Retirement of the DMS regarding any change in termination date and program participation for each affected member, etc.

[SB 1242](#) – Carrying of Weapons and Firearms by Steube (I: [HB 739](#) by Fant)

Providing that specified provisions relating to the carrying of weapons and firearms do not apply to persons engaged in, traveling to, or returning from certain outdoor activities or traveling to or returning from certain motor vehicles, residences, shelters, and other places; etc.

[SB 1244](#) – Developments of Regional Impact by Lee (I: [HB 1151](#) by La Rosa)

Revising the statewide guidelines and standards for developments of regional impact; specifying that amendments to a development order for an approved development may not alter the dates before which a development would be subject to downzoning, unit density reduction, or intensity reduction, except under certain conditions; requiring local governments to file a notice of abandonment under certain conditions; etc.

[HB 1251](#) – Florida Construction Workforce Task Force by Porter (I: [SB 1642](#) by Perry)
Requires DOE to submit to Governor & Legislature a plan regarding recommendations by Florida Construction Workforce Task Force by specified date.

[SB 1254](#) – Early Learning by Passidomo (S: [HB 1091](#) by Grall)
Requiring a parent with custody of a child to be verified as a victim of domestic violence by a certified domestic violence center before his or her child is considered an “at-risk child”; requiring each early learning coalition’s school readiness program plan to include a specified assessment; requiring a school readiness program provider to participate in specified assessments and strategies under certain circumstances; etc.

[HB 1255](#) – Student Discipline by Antone (S: [SB 1626](#) by Powell)
Revises duties of district school boards relating to student discipline & school safety & qualifications of school resource officer & school safety officer; requires district school board to adopt policy on referrals to criminal justice system or juvenile justice system, rather than zero tolerance policy.

[SB 1258](#) – Florida Security for Public Deposits Act by Hutson (S: [HB 769](#) by Trumbull)
Specifying conditions that must be met before the Chief Financial Officer may designate a credit union as a qualified public depository; requiring the Chief Financial Officer to segregate and separately account for certain proceeds, assessments, or penalties; etc.

[SB 1266](#) – Disclosure of Financial Interests by Thurston (S: [HB 925](#) by Newton)
Defining the term “charter school employee”; providing financial disclosure requirements for charter school employees; etc.

[HB 1269](#) – K-12 Classroom Teachers by Asencio (S: [SB 1704](#) by Taddeo)
Establishes Blue Ribbon Panel Task Force on Teacher Recruitment, Certification, & Retention within DOE; revises provisions relating to educator certification requirements, educator certification examinations, & educator certification fees.

[SB 1272](#) – Educational Choice Programs by Steube
Authorizing Gardiner Scholarship Program funds to be spent for specified school supplies; requiring the Auditor General to conduct operational audits of program participants at least once every 3 years; revising student eligibility requirements for the Florida Tax Credit Scholarship Program; capping the amount of eligible contributions that an organization may use for administrative expenses; providing a maximum application fee that an organization may charge for specified applicants; etc.

[HB 1279](#) – School District Accountability by Sullivan (S: [SB 1804](#) by Stargel)
Revises duties of Auditor General; revises provisions relating to Office of Inspector General, district school boards, school district superintendents, Commission on Ethics, & DOE duties & responsibilities.

[SB 1286](#) – The Gardiner Scholarship by Simmons
Revising the meaning of a rare disease within the definition of a “disability” for purposes of the Gardiner Scholarship Program; etc.

[SB 1288](#) – Tobacco Products by Simmons (S: [HB 1029](#) by Hahnfeldt and Berman)
Revising shipping documentation requirements for specified sales of tobacco products; revising the age limit for smoking near school property; prohibiting certain entities from gifting sample tobacco products to persons under 21 years of age; etc.

[SB 1290](#) – Government Actions Discriminating Against Businesses by Baxley (I: [HB 871](#) by Fant)
Citing this act as the “Free Enterprise Protection Act”; prohibiting certain discriminatory actions by governmental entities against business entities; etc.

[HB 1291](#) – Medical Use of Marijuana in Schools by Drake (S: [SB 986](#) by Montford)

Provides procedure & conditions for parent of student who is qualified patient to request assistance with the administration of medical marijuana during school day; requires school principal who receives request authorizing administration of marijuana to notify health department; provides procedures & authorization for designated caregivers to administer marijuana during school day; requires designated area on school grounds for administering marijuana; provides funding; etc.

[HB 1297](#) – Early Childhood Education by Brown (I: [SB 1738](#) by Stewart)

Prohibits private prekindergarten provider from participating in VPK for specified period under certain circumstances; prohibits private prekindergarten provider from participating in school readiness program for specified period under certain circumstances.

[HB 1299](#) – Public School Transportation by Raburn (S: [SB 188](#) by Steube)

Requires school boards to provide transportation to certain students; revises speed & road conditions that meet hazardous walking criteria; requires school superintendent to request review of hazardous walking condition under certain circumstance; requires school district to initiate specified proceedings.

[SB 1306](#) – Reading Instruction by Perry (I: [HB 887](#) by Harrell)

Requiring K-12 comprehensive reading plans to provide for intensive reading interventions that are delivered by teachers who meet certain criteria beginning with a specified school year; requiring DOE to consider the award of endorsements for a teaching certificate who meet certain requirements; requiring school districts to provide access to training sufficient for certain instructional personnel to earn an endorsement in reading; etc.

[SB 1310](#) – Postsecondary Educational Institutions by Rodriguez

Revising the required disclosures specified institutions must make to each prospective student; authorizing the Commission for Independent Education, under certain circumstances, to prohibit the enrollment of new students or to limit the number of students in a program at a licensed institution; etc.

[SB 1318](#) – Education For Prisoners by Rouson (S: [HB 1201](#) by Ahern)

Authorizing the Department of Corrections to contract with certain entities to provide educational services for the Correctional Education Program; removing a provision prohibiting state funds for the operation of post-secondary workforce programs from being used for the education of certain state inmates; etc.

[SB 1324](#) – Instructional Personnel and Administrator Salaries by Mayfield (S: [HB 427](#) by Plasencia)

Authorizing a district school board to use an advanced degree in setting a salary schedule for specified employees; authorizing, rather than requiring, a district school board to adopt a performance salary schedule; providing requirements for setting the base salary for specified personnel under the performance salary schedule; etc.

[HB 1331](#) – Florida Bright Futures Scholarship Program by Smith (I: [SB 1752](#) by Torres)

Removes condition under which student may use Florida Bright Futures Scholarship Program award for summer term enrollment & provides funding; revises certain initial eligibility criteria for specified awards under program; specifies amounts of certain awards eligible to cover specified expenses.

[HB 1333](#) – Enforcement of Federal Laws by Smith (S: [SB 1726](#) by Torres)

Prohibits state & local law enforcement agencies, school officers, & security agencies, from certain actions for purposes of immigration enforcement; requires agencies to review & revise confidentiality policies; prohibits agencies from making inquiry or recording information concerning person's immigration status; requires AG, certain educational institutions, and other entities to develop & publicize certain policies; etc.

[SB 1334](#) – Early Childhood Education by Baxley (S: [HB 1135](#) by Ausley)

Requiring schools designated as one of the 300 lowest-performing elementary schools to include an Early Childhood Transition Team in their required school improvement plans; requiring the team to develop a transition plan that contains certain elements; etc.

[SB 1342](#) – Florida Statutes by Benacquisto (I: [HB 7023](#) by Rules & Policy)

Deleting provisions that have expired, have become obsolete, have had their effect, have served their purpose, or have been impliedly repealed or superseded; etc.

[HB 1343](#) – School Health Immunizations by Mercado (I: [SB 1558](#) by Rodriguez)

Revises child immunization requirements to include vaccine for human papillomavirus.

[SB 1344](#) – Florida Statutes by Benacquisto (I: [HB 7025](#) by Rules & Policy)

Deleting provisions which have become inoperative by noncurrent repeal or expiration and may be omitted from the 2018 Florida Statutes only through a reviser's bill duly enacted by the Legislature; etc.

[HB 1365](#) – Early Learning by Grall (S: [SB 1822](#) by Hukill)

Requires Office of Early Learning to adopt observation-based child assessment system, subject to appropriation; conforms provisions to changes made by the act.

[HB 1371](#) – State Employee Higher Education Fee Waivers by Ausley (I: [SB 252](#) by Steube)

Provides that credit hours eligible for tuition & fee waivers be determined on calendar year basis, rather than per academic term.

[HB 1373](#) – Persons with Developmental Disabilities by Stevenson (S: [SB 1788](#) by Passidomo)

Prohibits granting of new or renewal of existing licenses for comprehensive transitional education programs after specified dates; revises competency assessment & validation requirements for direct service providers who administer or supervise self-administration of medication.

[HB 1377](#) – Baker Act by Silvers (S: [SB 1790](#) by Powell)

Requires DCF to create workgroup to provide recommendations for revising Baker Act; requires workgroup to submit report to specified entities & Legislature; providing duties of receiving facility administrator & court when persons under age 18 are admitted for voluntary mental health services or transferred to voluntary status. [Linked to [HB 1379](#) providing a public records exemption]

[SB 1380](#) – Regional Agency/Planning Council Meetings by Rodriguez (I: [HB 611](#) by Geller)

Providing requirements for establishing a quorum for meetings of certain agencies and councils when a voting member appears via telephone, real-time videoconferencing, or similar real-time electronic or video communication; requiring notice of intent to appear; etc.

[SB 1388](#) – Preapprenticeship and Apprenticeship Programs by Garcia (S: [HB 711](#) by Asencio)

Creating the Earn and Learn Grant Program within the Department of Education; specifying the purpose of the program; providing requirements for receiving grant funds; establishing the Task Force on Apprenticeship Expansion within the Department of Economic Opportunity; etc.

[HB 1391](#) – Sexual Offenses Against Students by Rodrigues

Prohibits certain conduct with students by authority figures; requires school districts to adopt certain standards of ethical conduct; expands scope of persons subject to disqualification from employment to apply to all school district employees whose positions require contact with students; requires superintendent to report certain misconduct to law enforcement; requires specified notice be provided to parents of certain alleged misconduct by an educator; etc.

[SB 1392](#) – Prearrest Diversion Programs by Brandes (S: [HB 1197](#) by Ahern)

Encouraging counties, municipalities, and public or private educational institutions to implement prearrest diversion programs; requiring, rather than authorizing, the FDLE to adopt rules for the expunction of certain nonjudicial records of the arrest of a minor upon his or her successful completion of a certain diversion program; etc. [Linked to [SB 1394](#) providing a public records exemption.]

[HB 1399](#) – Child Psychological Abuse by Antone (S: [SB 1724](#) by Torres)

Revises definition of "harm" & provision relating to mandatory reporting requirements to include child psychological abuse; requires Board of Psychology within DOH to revise continuing education requirements for renewal of license to practice psychology to include child psychological abuse.

[HB 1419](#) – Firearms by McClure (S: [SB 1048](#) by Baxley)

Authorizes religious institution to allow concealed weapons or concealed firearms licensee to carry firearm on property of institution for certain purposes.

[SB 1426](#) – Local Government Fiscal Transparency by Lee (S: [HB 7](#) by Burton)

Expanding the scope of the Legislative Auditing Committee review to include compliance with local government fiscal transparency requirements; creating the "Local Government Fiscal Transparency Act"; requiring local governments to post certain voting record information on their websites; etc.

[HB 1431](#) – School-Level Funding by Russell (I: [SB 1152](#) by Garcia)

Revises types of funds school districts may withhold before allocating certain Title 1 funds to eligible schools.

[SB 1434](#) – K-12 Education Enhancements by Passidomo

Creating the mental health assistance allocation and providing the purpose of the allocation; increasing the amount that a school district may expend from a specified millage levy for certain expenses; prohibiting a charter school from being eligible for capital outlay funds unless the chair of the governing board and the chief administrative officer of the charter school annually certify certain information, etc.

[HB 1437](#) – Employment Services for Persons with Disabilities by Abruzzo (I: [SB 648](#) by Baxley)

Specifies that participants in certain disabled persons' work experience activities are considered state employees for workers' compensation purposes.

[HB 1441](#) – Minimum Wage by Jacquet (S: [SB 166](#) by Rodriguez)

Revises formula for adjusted state minimum wage.

[HB 1443](#) – Disaster Response and Preparedness by Alexander (I: [SB 1006](#) by Montford)

Directs Division of Emergency Management to include specified persons in state emergency management plan & public awareness programs, provide guidance regarding Federal Government reimbursements, develop specified informational materials & evacuation strategies; requires certain shelters to accept service & comfort animals; requires FCS institutions & state universities to participate in emergency management activities under certain conditions; excludes certain students from school performance calculations & provides for payment of school district salaries during state of emergency.

[SB 1456](#) – Disaster Recovery Services Contracts by Garcia (I: [HB 1087](#) by Watson)

Authorizing a political subdivision, under specified circumstances, to add vendors to a contract or enter into a second contract for debris removal services after a declared state of emergency; etc.

[SB 1520](#) – Licensure of Child Care Programs by Hutson (S: [HB 1129](#) by Cortes)

Requiring certain organizations offering child care through after-school programs to be licensed as child care facilities; etc.

[SB 1532](#) – Early Learning Coalitions by Stargel (I: [HB 1175](#) by Sullivan)

Authorizing an early learning coalition to refuse to contract with certain school readiness program providers; etc.

[SB 1534](#) – Government Integrity by Mayfield (C: [HB 7003](#) by Public Integrity & Ethics)

Requiring the Chief Inspector General and each agency inspector general, respectively, to determine within a specified timeframe whether reasonable cause exists to believe that fraud, waste, abuse, mismanagement, or misconduct in government has occurred; prohibiting statewide elected officers and legislators from soliciting employment offers or investment advice arising out of official or political activities; etc. [Linked to [SB 1536](#) creating a trust fund for lobbyist registration fees]

[SB 1540](#) – Powers and Duties of a District School Board by Braynon (S: [HB 6055](#) by Williams)

Deleting a provision prohibiting a district school board from awarding an annual contract on the basis of certain circumstances; etc.

[SB 1544](#) – Speech-language Pathologists/School District by Farmer

Providing requirements for the caseloads of speech-language pathologists employed by a school district; requiring school districts to use certain student counts to determine caseloads; etc.

[SB 1546](#) – Voluntary Prekindergarten Education Program by Simmons

Revising VPK program options available to certain parents to include a specified in-home, technology-based program; requiring the Office of Early Learning to adopt certain procedures and criteria regarding a nonprofit provider's kindergarten readiness rate; requiring the office to adopt certain procedures for the VPK Program for a nonprofit provider; etc.

[SB 1548](#) – K-12 Student Safety by Book (S: [HB 777](#) by Moskowitz)

Exempting certain school district employees from level 2 background screenings under specified circumstances; prohibiting certain teachers from receiving bonuses related to specified FTE student membership calculations; requiring certified educators to inform their employers within a specified time period after being arrested for, rather than convicted of, certain offenses; etc.

[SB 1554](#) – Charter Schools by Rodriguez (*House companion bill withdrawn*)

Requiring charter schools that receive capital outlay funding used for certain purposes to ensure that new facilities comply with the State Requirements for Educational Facilities of the Florida Building Code; etc.

[SB 1556](#) – Education Facilities as Emergency Shelters by Rodriguez (I: [HB 779](#) by Cruz)

Requiring that education facilities that have received public education capital outlay funding be made available to county and state emergency management offices during a state of emergency for specified purposes; etc.

[SB 1558](#) – School Health Immunizations by Rodriguez (I: [HB 1343](#) by Mercado)

Citing this act as the “Women’s Cancer Prevention Act”; revising child immunization requirements to include a vaccine for human papillomavirus; etc.

[SB 1566](#) – Military and Veteran Support by Grimsley (S: [HB 1191](#) by Latvala)

Requiring the Department of Education to expedite the processing of an application for educator certification submitted by the spouse of a servicemember stationed in this state; requiring the State Board of Education to adopt rules regarding extending validity of a temporary certificate; etc.

[SB 1568](#) – Prohibited Activities/Workers’ Compensation Law by Farmer

Requiring employers to comply with specified provisions relating to the unlawful employment of aliens, unfair immigration-related employment practices, and penalties for document fraud; etc.

[SB 1578](#) – Student Assessments by Stewart

Requiring the Commissioner of Education to identify concordant and comparative scores on specified Spanish language college admission tests that satisfy certain graduation requirements; etc.

[SB 1598](#) – Deployed Parent Custody and Visitation by Passidomo (I: [HB 1217](#) by Metz)

Providing requirements for proceeding for custodial responsibility of a child of a servicemember; authorizing a court to grant caretaking authority or limited contact to a nonparent under certain conditions; providing for the termination of a grant of authority; etc.

[SB 1610](#) – School Meals by Farmer (*House companion bill withdrawn*)

Requiring schools to provide certain information relating to free and reduced-price meals; requiring schools to complete an application for free or reduced-price meals on a student's behalf under certain circumstances; requiring a liaison to work with DACS to ensure certain students receive meals; etc.

[SB 1614](#) – Education by Hukill

Requiring the Department of Education to suspend specified payments to private schools that fail, rather than knowingly fail, to meet certain scholarship program accountability standards; providing that the failure of, rather than the inability of, private schools to meet such standards constitutes the basis for ineligibility for participation in a scholarship program; etc.

[SB 1616](#) – Education by Hukill

Requiring school districts to conduct a security risk assessment at each public school site within the district; requiring school districts to use a format prescribed by the Department of Education for such assessments and for self-assessments of current safety and security practices; etc.

[SB 1618](#) – Education by Hukill

Removing an obsolete date relating to IEP; etc.

[SB 1626](#) – Student Discipline by Powell (S: [HB 1255](#) by Antone)

Revising the qualifications of a school resource officer and a school safety officer; requiring each district school board to adopt a policy on referrals to the criminal justice system or the juvenile justice system, rather than a policy of zero tolerance for crime and victimization; etc.

[SB 1628](#) – Sexual Harassment by Book (S: [HB 1233](#) by Jacobs)

Creating the Task Force on the Prevention of Sexual Harassment and Misconduct; prohibiting public officers, qualified candidates, agency employees, and lobbyists from sexually harassing any person; specifying that the personal identifying information of an alleged victim of sexual harassment remains confidential and exempt from public records requirements; etc.

[SB 1642](#) – Florida Construction Workforce Task Force by Perry (I: [HB 1251](#) by Porter)

Requiring the Department of Education to submit to the Governor and the Legislature a plan regarding recommendations by the Florida Construction Workforce Task Force by a specified date; etc.

[SB 1644](#) – Instructional Materials by Lee (C: [HB 827](#) by Donalds)

Requiring district school board rules to include a longer public review period for student editions of recommended instructional materials; requiring public access to and an opportunity to comment on instructional materials recommended for adoption; exempting certain instructional materials from certain public review procedures; etc.

[SB 1650](#) – Child Abuse, Abandonment, and Neglect by Montford

Prohibiting the Department of Children and Families from releasing the names of certain persons who have provided information during a protective investigation except under certain circumstances; etc.

[SB 1656](#) – Public Educational Facilities by Lee (S: [HB 1023](#) by Duran)

Providing requirements for determining the capacity of facilities in certain schools as reported in the Florida Inventory of School Houses; authorizing a district school board to submit an application to the Commissioner of Education for an exemption for a facility from the State Requirements for Educational Facilities; etc.

[SB 1660](#) – Mandatory Retention of Grade 3 Students by Farmer (I: [HB 6063](#) by Dubose)

Deleting provisions relating to the mandatory retention of students who receive specified scores on the grade 3 statewide, standardized English Language Arts assessment; etc.

[SB 1662](#) – Education by Farmer

Requiring the annual notice of student and parent rights regarding education records to include information on opting out of disclosing a student's directory information; requiring each district school board to adopt rules prohibiting the distribution or communication of political materials that do not meet specified requirements; etc.

[SB 1666](#) – Student Mental Health Day by Farmer

Recognizing January 12, 2018, as "Student Mental Health Day" in Florida; etc.

[SB 1670](#) – Inmates and Higher Education by Farmer (I: [HB 6035](#) by Edwards)

Deleting a provision prohibiting certain state funds from being used for the education of state or federal inmates; deleting a provision prohibiting the instruction of state inmates from being included in specified enrollment for certain education funding; etc.

[SB 1672](#) – Charter Schools by Farmer

Revising the fiscal responsibility requirements for the charter school application and review process; requiring private property taken by eminent domain for a public school purpose or use to be used only for traditional public schools; authorizing, rather than requiring, a school district to distribute specified funding to eligible charter schools in its district; etc.

[SB 1680](#) – Immunization Registry by Montford (S: [HB 1045](#) by Pigman)

Provides requirements for electronic availability of immunization records; revises school-entry health requirements to require students have certificate of immunization on file with immunization registry; etc.

[SB 1684](#) – School Improvement by Simmons

Revising duties of the State Board of Education; requiring intervention and support strategies for certain traditional public schools to include extended learning hours; modifying the turnaround options available for certain schools within the school district under certain circumstances; etc.

[SB 1690](#) – Charter School Employees by Farmer

Requiring each charter school principal, chief financial officer, or their equivalent, to meet certain certification requirements; etc.

[SB 1692](#) – The Florida Retirement System by Torres (I: [HB 1209](#) by Asencio)

Revising provisions related to the early retirement benefit calculation and the deferred retirement option program; revising provisions related to the benefit commencement age and creditable years of service for investment plan participants to conform to changes made by the act; etc.

[SB 1700](#) – School Resource Officer Programs by Torres

Encouraging district school boards to place a school resource officer at each public school; authorizing part-time law enforcement officers to serve as school resource officers or safety officers; providing requirements for the funding of the salaries of certain school resource officers and safety officers; etc.

[SB 1704](#) – K-12 Classroom Teachers by Taddeo (S: [HB 1269](#) by Asencio)

Establishing the Blue Ribbon Panel Task Force on Teacher Recruitment, Certification, and Retention within the DOE; providing that the Graduate Management Admissions Test and a Graduate Record Examination subject area test may be used to meet certain educator certification requirements; waiving certain application and examination fees; etc.

[SB 1724](#) – Child Psychological Abuse by Torres (S: [HB 1399](#) by Antone)

Expanding the definition of the term “harm” to include the infliction of certain mental injury on a child; revising a provision relating to mandatory reporting requirements for child abuse, abandonment, or neglect to include child psychological abuse; etc.

[SB 1726](#) – Enforcement of Federal Laws by Torres (S: [HB 1333](#) by Smith)

Prohibiting state and local law enforcement agencies, school law enforcement officers, and security agencies from certain actions for purposes of immigration enforcement; prohibiting state and local law enforcement agencies and health care providers from making an inquiry or recording information concerning the immigration status of certain persons; etc.

[SB 1730](#) – School Bus Safety by Torres

Providing that a person using, operating, or driving a vehicle who passes a school bus on the side that children enter and exit while the school bus displays a stop signal commits reckless driving, rather than a moving violation; etc.

[SB 1732](#) – School Garden Programs by Torres

Requiring the Department of Education, in collaboration with the Department of Agriculture and Consumer Services, to annually provide to school districts certain information relating to school garden programs; authorizing schools that establish a school garden program to allow certain students to select and receive produce from the garden on a specified day each week; etc.

[SB 1736](#) – Florida Tax Credit Scholarship Program by Stewart

Revising the fiscal responsibility requirements for a private school that receives funds under the Florida Tax Credit Scholarship Program; providing qualification requirements for school administrators who are employed at such schools; etc.

[SB 1738](#) – Early Childhood Education by Stewart (I: [HB 1297](#) by Brown)

Prohibiting a private prekindergarten provider from participating in the VPK Program for a specified period under certain circumstances; authorizing an early learning coalition to revoke the eligibility of a school readiness program provider under certain circumstances; etc.

[SJR 1742](#) – Supermajority Vote for State Taxes or Fees by Stargel (S: [HJR 7001](#) by Ways & Means)

Requiring a law that imposes a new tax, increases the rate or amount of a tax, or expands a tax base, and that results in a net increase in state revenues, to be approved by three-fifths of the membership of each house of the Legislature; etc.

[SB 1746](#) – Equity in School-Level Funding Act by Thurston

Repealing provisions relating to the Equity in School-Level Funding Act; etc.

[SB 1750](#) – Ethics by Rodriguez

Prohibiting a state public officer from voting in an official capacity on any measure that he or she knows would inure to the special private gain or loss of certain principals, parent organizations or subsidiaries of a corporate principal, relatives, or business associates of the officer; revising disclosure requirements; authorizing a person who has filed a complaint against a public officer or employee to recover costs and reasonable attorney fees if he or she prevails; etc.

[SB 1752](#) – Florida Bright Futures Scholarship Program by Torres (I: [HB 1331](#) by Smith)
Citing this act as the y be cited as the “Restore Our Bright Futures Act”; revising the initial eligibility criteria for certain Florida Bright Futures Scholarship Program awards; specifying the amounts of the Florida Academic Scholars and Florida Medallion Scholars awards eligible to cover tuition, fees, textbooks, and other college-related expenses; etc.

[SB 1756](#) – School Accountability by Simmons
Revising the private schools to which the Department of Education is required to provide technical assistance and authorized staff; revising requirements for private schools that participate in the Gardiner Scholarship Program; revising the purpose of department site visits at private schools participating in the John M. McKay Scholarships for Students with Disabilities Program; requiring a private school to employ or contract with teachers who meet certain qualifications and provide information about such qualifications to the department; etc.

[SB 1762](#) – Training for Secondary School Nurses by Campbell
Requiring a school health services plan to provide for the training of secondary school health nurses to help them identify and respond appropriately to students who are victims of rape; etc.

[SB 1772](#) – Charter School Capital Outlay Funding by Montford
Increasing the maximum number of years for which a specified millage may be levied; requiring the Office of Program Policy Analysis and Government Accountability, in conjunction with the Office of the Auditor General, to conduct certain studies and provide reports that meet specified requirements to the Governor and the Legislature by a specified date, etc.

[SB 1788](#) – Agency for Persons With Disabilities by Passidomo (S: [HB 1373](#) by Stevenson)
Prohibiting the agency from issuing a license to a new comprehensive transitional education program after a specified date; prohibiting the agency from renewing the license of an existing comprehensive transitional education program after a specified date; revising competency assessment and validation requirements for direct service providers who administer or supervise the self-administration of medication, etc.

[SB 1790](#) – Baker Act by Powell (S: [HB 1377](#) by Silvers)
Requiring the Department of Children and Families to create a workgroup to provide recommendations relating to revision of the Baker Act; requiring the administrator of a receiving facility to file a petition for voluntary placement after a person under age 18 is admitted for services or transferred to voluntary status; requiring the administrator of a children’s crisis stabilization unit or a juvenile addictions receiving facility to file a petition for voluntary placement after a person under age 18 is admitted for services; etc. [Linked to [SB 1846](#) providing a public records exemption]

[SB 1804](#) – School District Accountability by Stargel (S: [HB 1279](#) by Sullivan)
Prohibiting former appointed district school superintendents from conducting certain lobbying activities; requiring the governing body of a school board to take specified actions; requiring the Office of Inspector General to investigate certain allegations and reports; requiring a district school board to limit certain expenditures if certain financial conditions exist for a specified period of time; etc.

[SB 1812](#) – Sovereign Immunity by Rader (S: [HB 1131](#) by Jenne)
Authorizing political subdivisions to insure for certain amounts to pay certain claims or judgments; prohibiting payments in excess of such insurance limits from such political subdivisions; authorizing counties to purchase umbrella policies to insure certain municipalities, etc.

[SB 1820](#) – Reading Scholarship Accounts by Perry
Establishing reading scholarship accounts for specified purposes; providing that funding shall be specified in the GAA; specifying that no state liability arises from the award or use of account; etc.

[SB 1822](#) – Early Childhood Learning by Hukill (S: [HB 1365](#) by Grall)

Requiring the Office of Early Learning to adopt an observation-based child assessment system that contains specified elements, under certain circumstances; requiring each early learning coalition to implement a specified age-appropriate observation-based assessment for certain children, rather than a pre-assessment and post-assessment; etc.

[SB 1828](#) – Employment Discrimination by Rodriguez (S: [HB 225](#) by Davis)

Prohibiting an employer from taking retaliatory personnel action against an employee who has left a place of employment to evacuate under an mandatory evacuation order; etc.

[SB 1848](#) – Florida Tax Credit Scholarship Program by Farmer (I: [HB 6051](#) by Shaw)

Repealing provisions relating to the Florida Tax Credit Scholarship Program; repealing provisions relating to credit for contributions to eligible nonprofit scholarship-funding organizations; etc.

[HB 6003](#) – Participant Local Government Advisory Council by White (I: [SB 614](#) by Montford)

Abolishes the Participant Local Government Advisory Council.

[HB 6009](#) – Write-In Candidates by Geller (I: [SB 582](#) by Rader)

Repeals provisions relating to write-in candidate residency requirement.

[HB 6035](#) – Inmates and Higher Education by Edwards (I: [SB 1670](#) by Farmer)

Deleting a provision prohibiting certain state funds from being used for the education of state or federal inmates; deleting a provision prohibiting the instruction of state inmates from being included in specified enrollment for certain education funding; etc.

[HB 6047](#) – Charter Schools Capital Outlay Funding by Newton

Repeals provisions relating to charter schools capital outlay funding.

[HB 6051](#) – The Florida Tax Credit Scholarship Program by Shaw (I: [SB 1848](#) by Farmer)

Repeals provisions relating to Florida Tax Credit Scholarship Program; repeals provisions relating to credit for contributions to eligible nonprofit scholarship-funding organizations.

[HB 6053](#) – School Grading System by Williams

Repeals provisions relating to school grading system, school report cards, & district grades.

[HB 6055](#) – Powers and Duties of a District School Board by Williams (S: [SB 1540](#) by Braynon)

Removes provision prohibiting district school board from awarding annual contract on basis of certain circumstances.

[HB 6061](#) – Best and Brightest Scholarship Programs by Ausley

Repeals Florida Best & Brightest Teacher Scholarship Program & Florida Best & Brightest Principal Scholarship Program.

[HB 6063](#) – Mandatory Retention of Grade 3 Students by DuBose (I: [SB 1660](#) by Farmer)

Removes provisions relating to mandatory retention of students who receive specified scores on grade 3 statewide, standardized English Language Arts assessment.

[HB 6065](#) – Higher Education Programs by Alexander

Repeals provisions relating to Florida College System Performance-Based Incentive, Distinguished Florida College System Institution Program, preeminent state research universities program, & State University System Performance-Based Incentive.

[HB 6067](#) – Education by Brown

Removes provision authorizing certain entities to be designated as local educational agency; removes provisions relating to Title I funding.

[HB 6069](#) – Requirements for Standard High School Diploma by Alexander

Removes requirement that at least one course required for receipt of standard high school diploma be completed through online learning.

[HJR 7001](#) – Supermajority Vote for State Taxes or Fees by Ways & Means (S: [SJR 1742](#) by Stargel)

Proposes amendment to State Constitution to prohibit a state tax or fee from being imposed or raised except through legislation approved by two-thirds of each house of legislature; requires a state tax or fee imposed or raised to be contained in separate bill that contains no other subject.

[HB 7003](#) – Local Government Ethics Reform by Public Integrity & Ethics (C: [SB 1534](#) by Mayfield)

Provides that contractual relationships held by business entities are deemed held by public officers or employees in certain situations; provides ethics training requirements; prohibits certain governing board members from voting in official capacity on specified matters; provides for future repeal of provisions relating to local government authority to enact rule or ordinance requiring lobbyists to register with local government; requires Commission on Ethics to create Local Government Lobbyist Registration System; requires lobbyists to register with commission before lobbying specified governmental entities; provides responsibilities of Governor; provides civil penalties. [Linked to [HB 7005](#) providing a trust fund for lobbyist registration fees.]

[HB 7007](#) – Ethics Reform by Public Integrity & Ethics

Repeals provisions relating to state, state university, & community college employee lobbyists; prohibits certain public service announcements; prohibits public officer/agency employee from soliciting specified employment/contractual relationships; authorizes Commission on Ethics to investigate certain disclosures; prohibits certain compensated representation for specified period following vacation of office; deletes provision prohibiting former legislators from acting as lobbyists before certain entities & persons for specified period following vacation of office; prohibits certain officers & employees from soliciting employment/contractual relationships from or negotiating same with certain employers; requires lobbyist to electronically register with commission; revises lobbyist registration, compensation report, principal designation cancellation, & investigation requirements.

[HB 7009](#) – Workers' Compensation by Commerce Committee

Requires panel to annually adopt statewide workers' compensation schedules of maximum reimbursement allowances; extends timeframes in which employees may receive certain workers' compensation benefits & in which carrier must notify treating doctor of certain requirements; revises provisions relating to retainer agreements & awarding attorney fees.

[HB 7011](#) – OGSR/School Food Program (SB 7016)

Relating to an exemption from public record requirements for personal identifying information of an applicant for or participant in a school food and nutrition service program; narrowing the application of the exemption; removing the scheduled repeal of the exemption; etc.

[HB 7017](#) – Child Exploitation by Criminal Justice (S: [SB 1214](#) by Book)

Authorizes subpoenas in certain investigations of sexual offenses involving child victims & specifies requirements; prohibits person from using child in sexual performance or promoting sexual performance by child; provides for separate offenses of computer pornography & child exploitation; prohibits person from possessing, with intent to promote, child pornography; prohibits person from knowingly possessing, controlling, or intentionally viewing child pornography; provides for separate offenses of transmission of child pornography. [Linked to [HB 7019](#) providing a public records exemption.]

[HB 7023](#) – Florida Statutes/General by Rules & Policy (I: [SB 1342](#) by Benacquisto)

Deletes provisions that have expired, have become obsolete, have had their effect, have served their purpose, or have been impliedly repealed or superseded; replaces incorrect cross-references & citations; corrects grammatical, typographical, & like errors; removes inconsistencies, redundancies, & unnecessary repetition in statutes; & improves clarity of statutes & facilitates their correct interpretation.

[HB 7025](#) – Florida Statutes/Repeals or Expiration by Rules & Policy (I: [SB 1344](#) by Benacquisto)

Repeals specified provisions that have become inoperative by noncurrent repeal or expiration & may be omitted from 2018 Florida Statutes only through reviser's bill duly enacted by Legislature.

[HB 7045](#) – Date for Convening the 2020 Legislative Session by Rules & Policy

The bill requires the 2020 regular session of the Legislature to convene on Tuesday, January 14, 2020.

[HB 7055](#) – Education by Education

Revises provisions relating to Commissioner of Education, DOE, school districts, school district superintendents, statewide, standardized assessments, charter schools, educational scholarship programs, principal autonomy pilot program initiative, dual enrollment, FLVS, & private schools.
