The year that you serve as President is a year that you can expect to be "on-call" for the entire year. You can receive 24 hours' notice that the Governor or other state leader may want to meet with you somewhere in Florida or state or national issues may arise that may require FSBA representation.

It is important as President of the organization that you are on call and available to receive calls from the FSBA office and can return the communications in a timely fashion. Staff will only call with time-sensitive deadlines when decisions need to be made, or clarification is needed.
